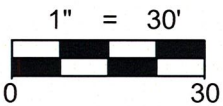
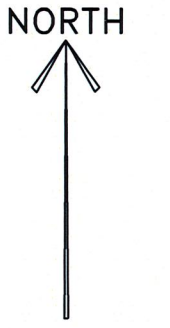
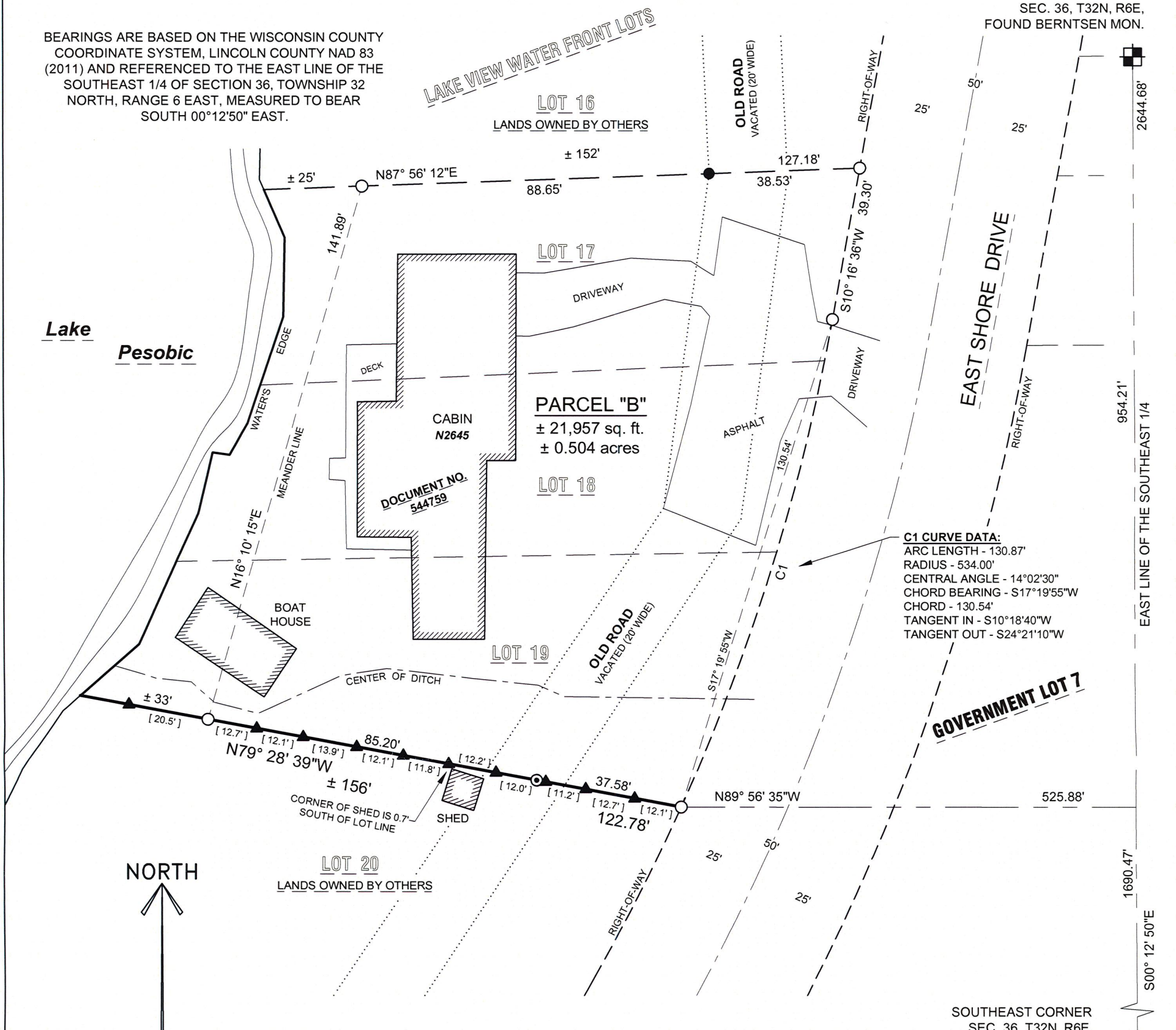


PLAT OF SURVEY

Of the South line of Lot 19 of the Plat of Lake View Water Front Lots and the extension thereof, located in part of Government Lot 7, Section 36, Township 32 North, Range 6 East, Town of Merrill, Lincoln County, Wisconsin.

BEARINGS ARE BASED ON THE WISCONSIN COUNTY COORDINATE SYSTEM, LINCOLN COUNTY NAD 83 (2011) AND REFERENCED TO THE EAST LINE OF THE SOUTHEAST 1/4 OF SECTION 36, TOWNSHIP 32 NORTH, RANGE 6 EAST, MEASURED TO BEAR SOUTH 00°12'50" EAST.



LEGAL DESCRIPTION

Of the South line Lot 19 of the Plat of Lake View Water Front Lots and the extension thereof, located in part of Government Lot 7 of Section 36, Township 32 North, Range 6 East, Town of Merrill, Lincoln County, Wisconsin, described as follows:

Commencing at the East 1/4 corner of said Section 36; Thence South 00°12'50" East along the East line of said Southeast 1/4, 954.21 feet; Thence North 89°56'35" West, 525.88 feet to a point on the West right-of-way line of East Shore Drive and the South Line of Lot 19 of the Plat of Lake View Water Front Lots and the extension thereof, said point being the point of beginning; Thence North 79°28'39" West along the South line of said Lot 19 and the extension thereof, 122.78 feet to the water's edge of Lake Pesobic and the termination of said line.

That said line is subject to all easements, restrictions and right-of-ways of record.
