 TOWN OF BIRCH, LINCOLN COUNTY, WI

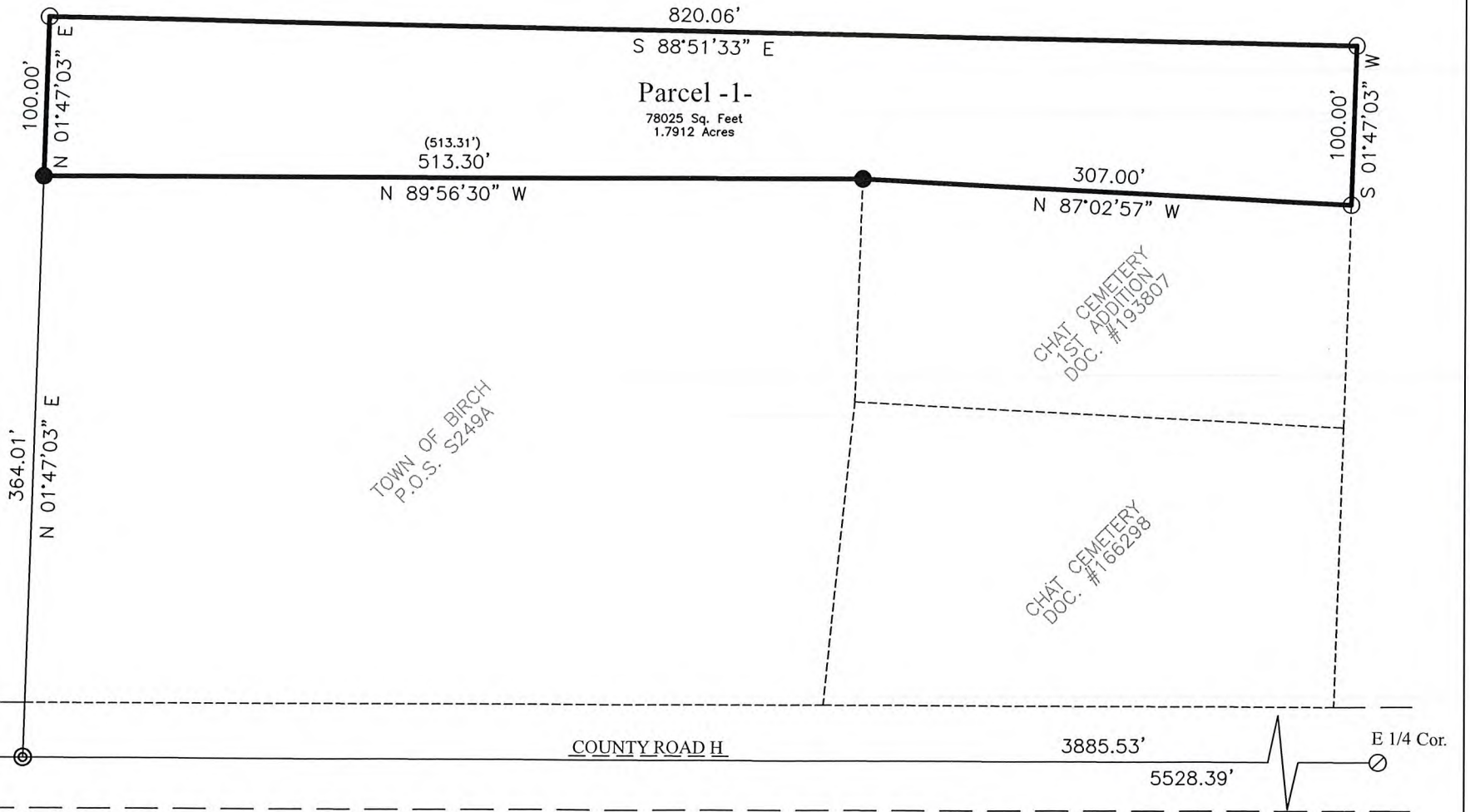

All that part of the Southeast Quarter of the Northwest Quarter (SE 1/4-NW 1/4), of Section Thirty (30), Township Thirty-Three (33) North, Range Seven (7) East, Town of Birch, Lincoln County, Wisconsin. More particularly described as follows:

Commencing at the West Quarter Corner of said Section Thirty (30); Thence S 89°51'36" E, coincident the East - West 1/4 Line, a distance of 1642.86 feet to a point; thence N 01°47'03" E, a distance of 364.01 feet to a 7/8" Iron Rod, also being the Point Of Beginning; thence continuing N 01°47'03" E, a distance of 100.00 feet to a 7/8" Iron Rod; thence S 88°51'33" E, a distance of 820.06 feet to a 7/8" Iron Rod; thence S 01°47'03" W, a distance of 100.00 feet to a 7/8" Iron Rod; thence N 87°02'57" W, a distance of 307.00 feet to a 7/8" Iron Rod; thence N 89°56'30" W, a distance of 513.30 feet to the Point Of Beginning.

Subject to easements and roadways of record.

Said parcel contains 1.79 Acres.

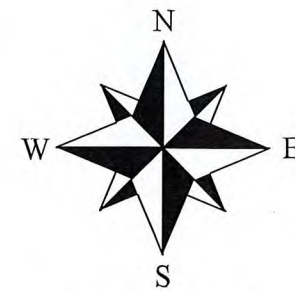

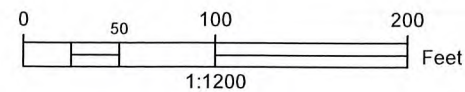
- 1.) PLSS Corners had all record witness monuments found in place.
