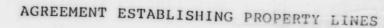

Re: All that part of Government Lot Eight (8) and the North-cast Quarter of the Southeast Quarter (NE¼ SE¼), Section Thirty-four (34), Township Thirty-five (35) North, Range Six (6) East bounded as follows: Bounded on the east by the city street known as Bradley Farm Road and also the easterly line of Government Lot Eight (8); bounded on the north by King Road; bounded on the west by the easterly line of the property described as Assessor's Plat Lot 75 of the Assessor's Plat of the City of Tomahawk; and bounded on the south by the northerly line of the Marinette, Tomahawk and Western Railway right-

- 1. The parties to this agreement are owners or have other interests in portions of the above described property.
- 2. An error in the starting point of an eighth corner in previous descriptions has caused certain "paper overlaps." The physical boundaries for the various parcels had been well set.
- 3. The individual properties have now been resurveyed and mapped by Timberland Surveyors, Inc., as Map #659. This has been based on physical boundaries as used by the owners over the years who were using an erroneous starting point. The parcels have been redescribed to match the physical boundaries.
- 4. The surveyor has assigned parcel numbers "1" through "11" to the various parcels on the map and each numbered parcel has a "metes and bounds" description which conforms in general with the physical boundary of the parcel. The "metes and bounds" descriptions of the parcels are attached.

NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:

- 5. The numbered parcel set opposite each property owner or owners shall be the physical and legal description of that owners' lot. This is shown on "EXHIBIT A".
- 6. To clarify title, each party disclaims any interest in any other parcel within the area excepting that described opposite such owner or owners name.
- 7. This shall bind and inure to the benefit of the parties, their heirs, successors and assigns.
- 8. It is also understood that this document may be signed using separate originals to make up one total agreement.
