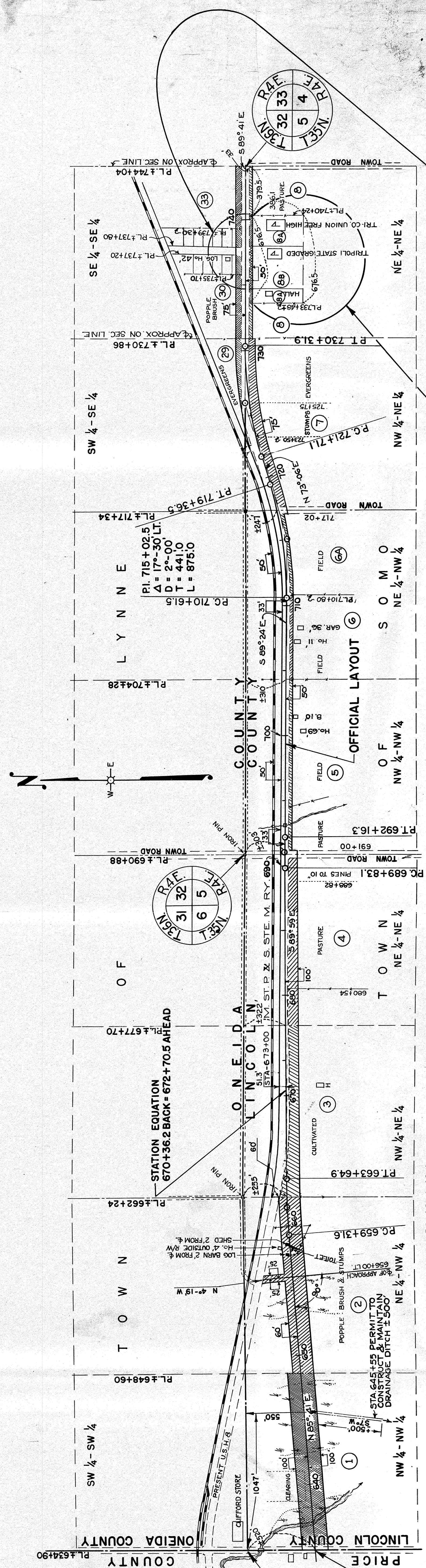

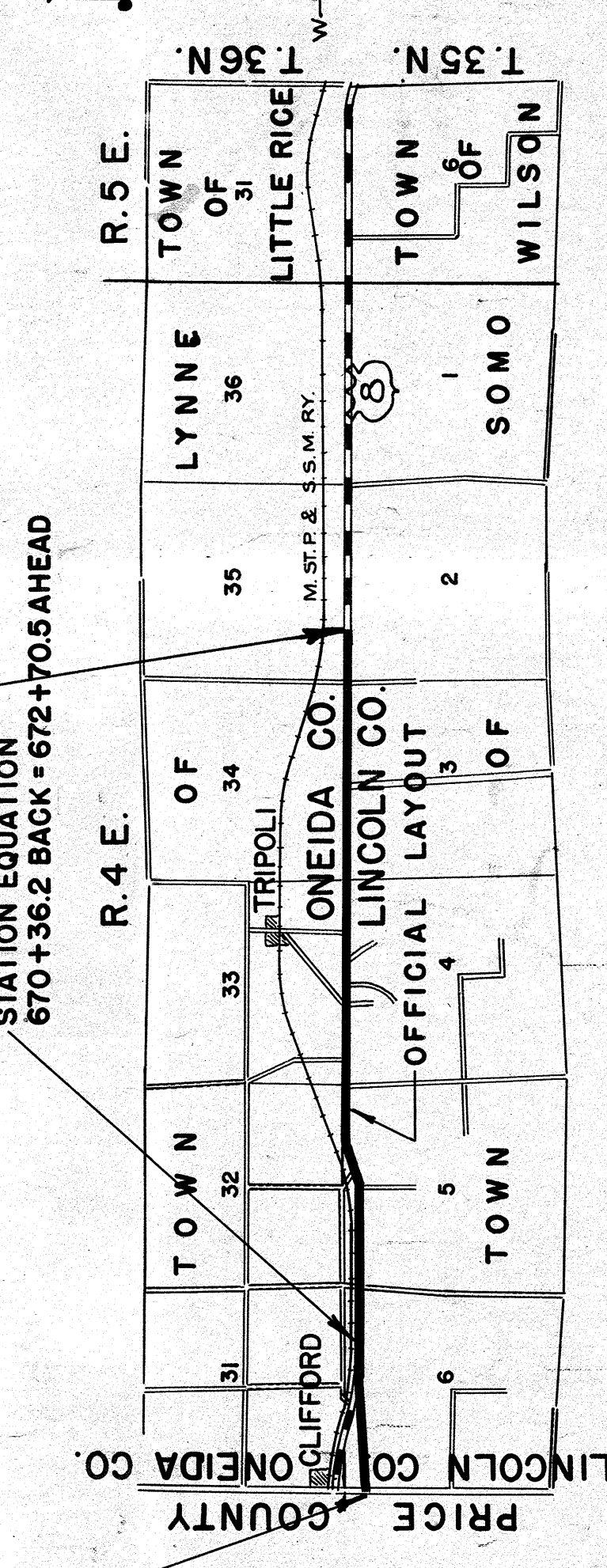

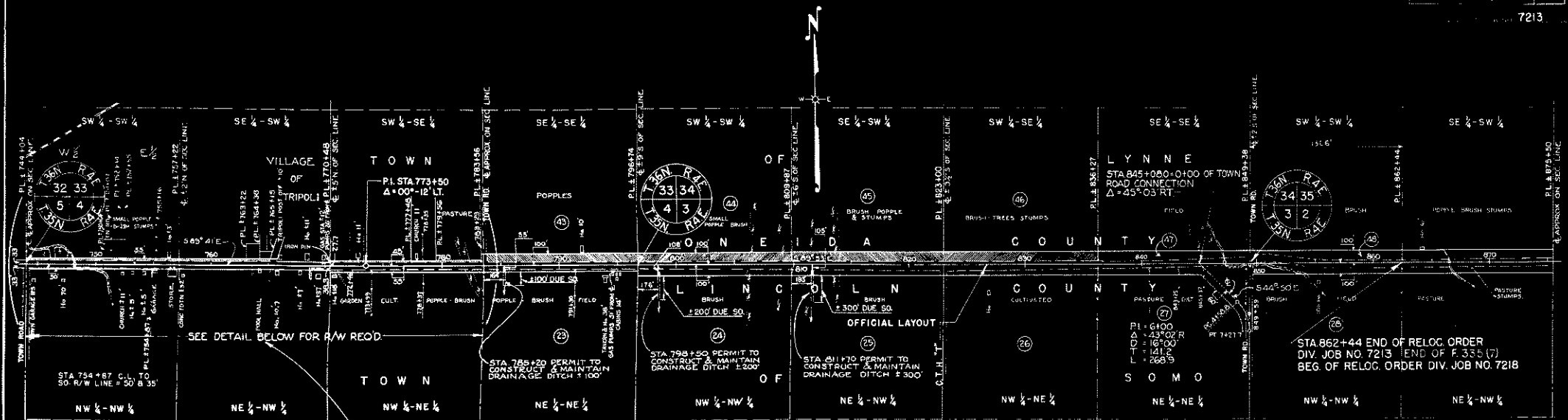


LOCATION SKETCH

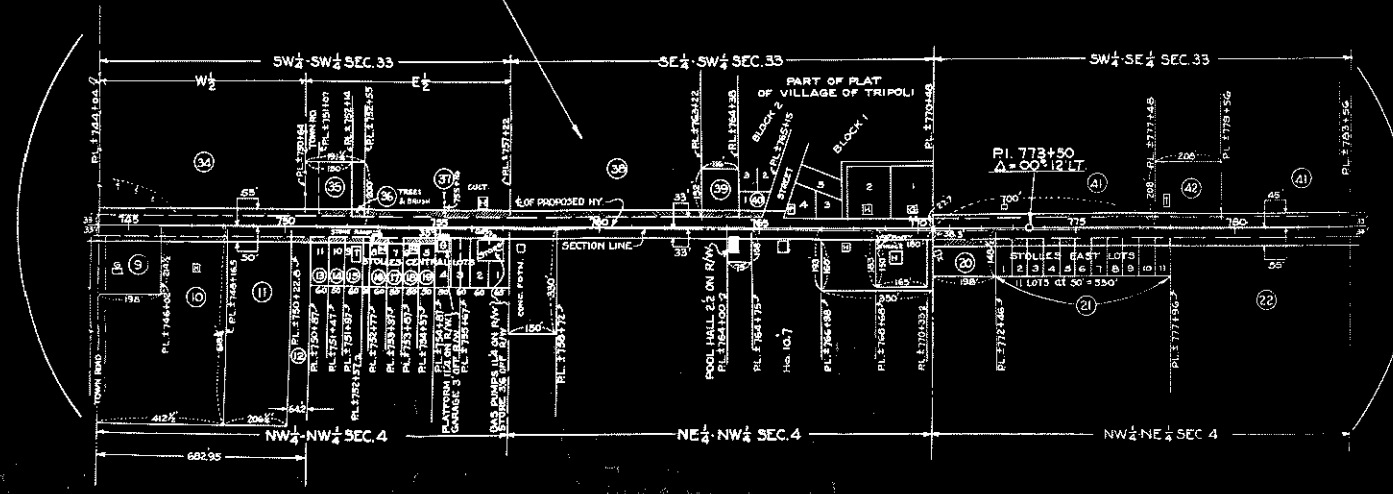
