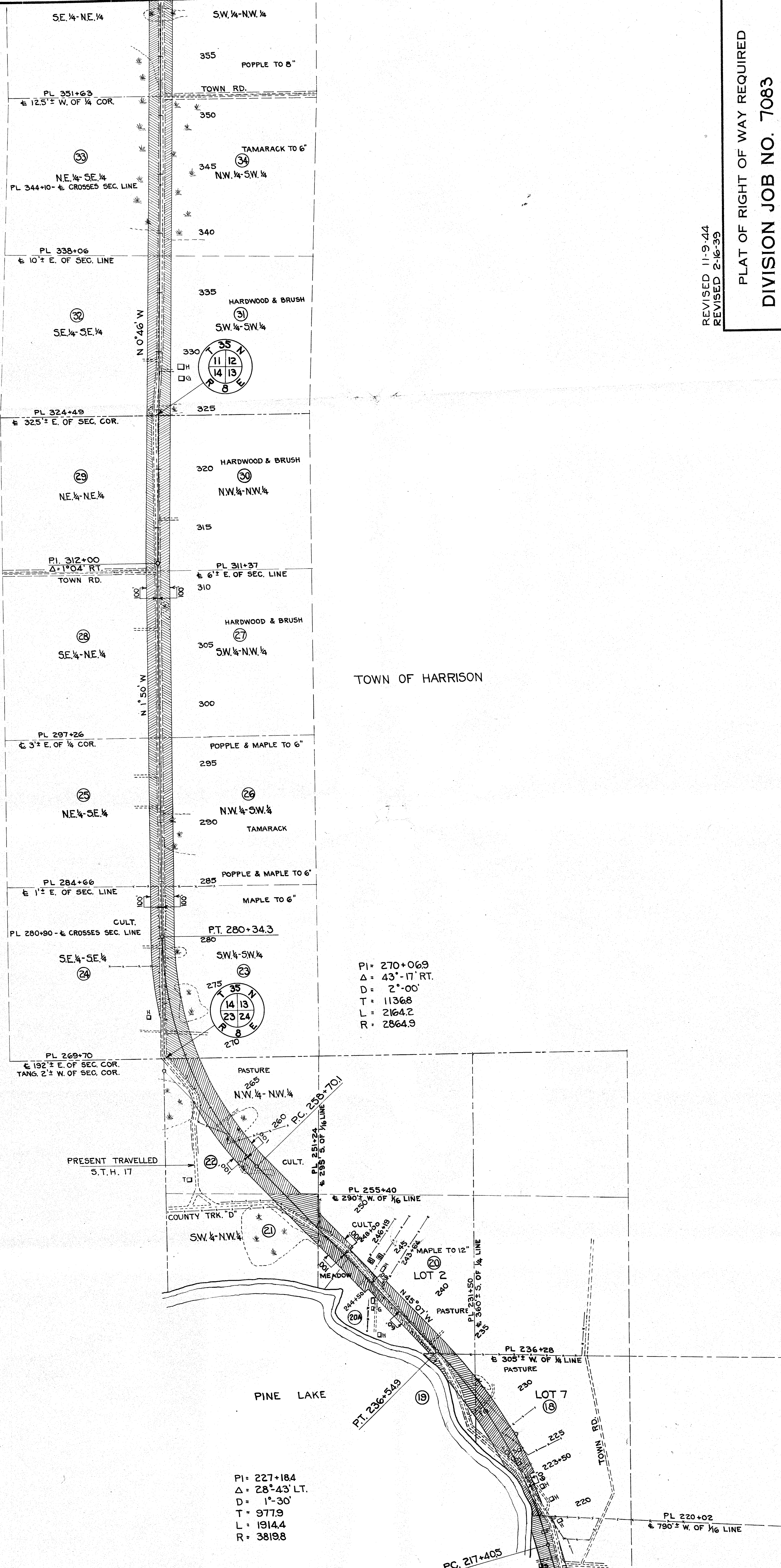

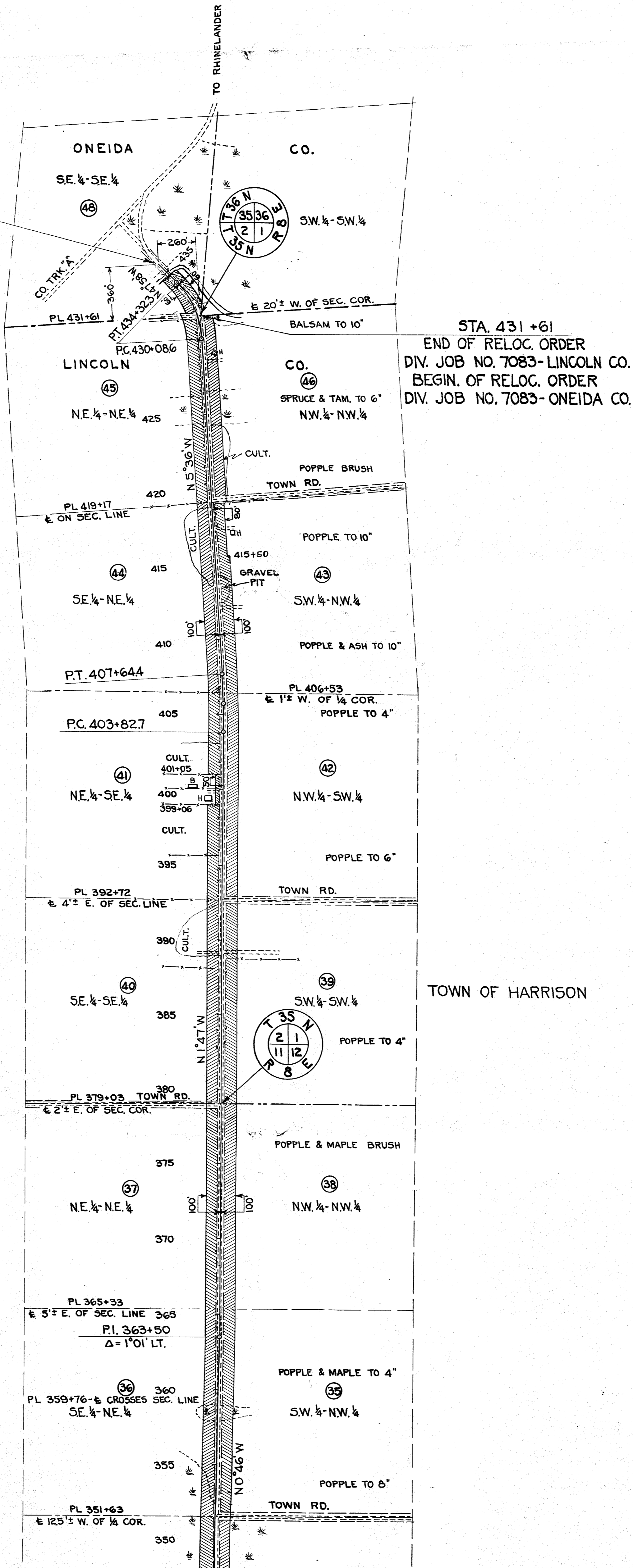
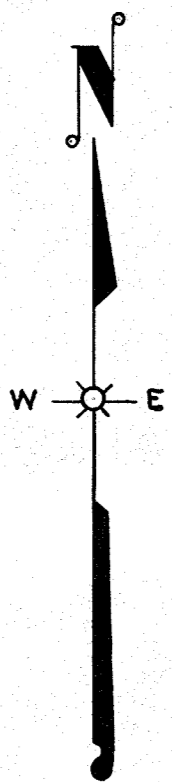
PLAT OF RIGHT OF WAY REQUIRED
