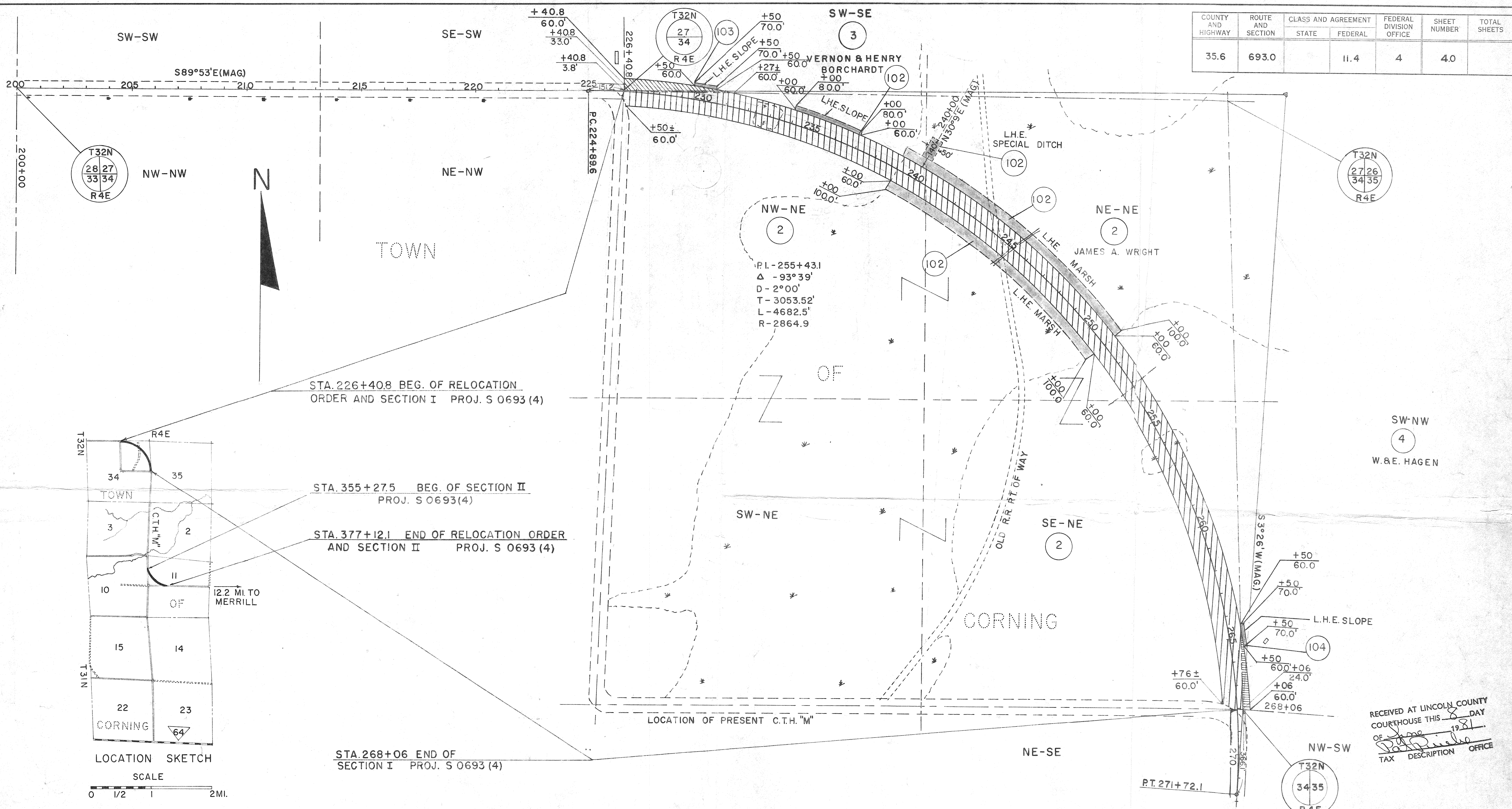

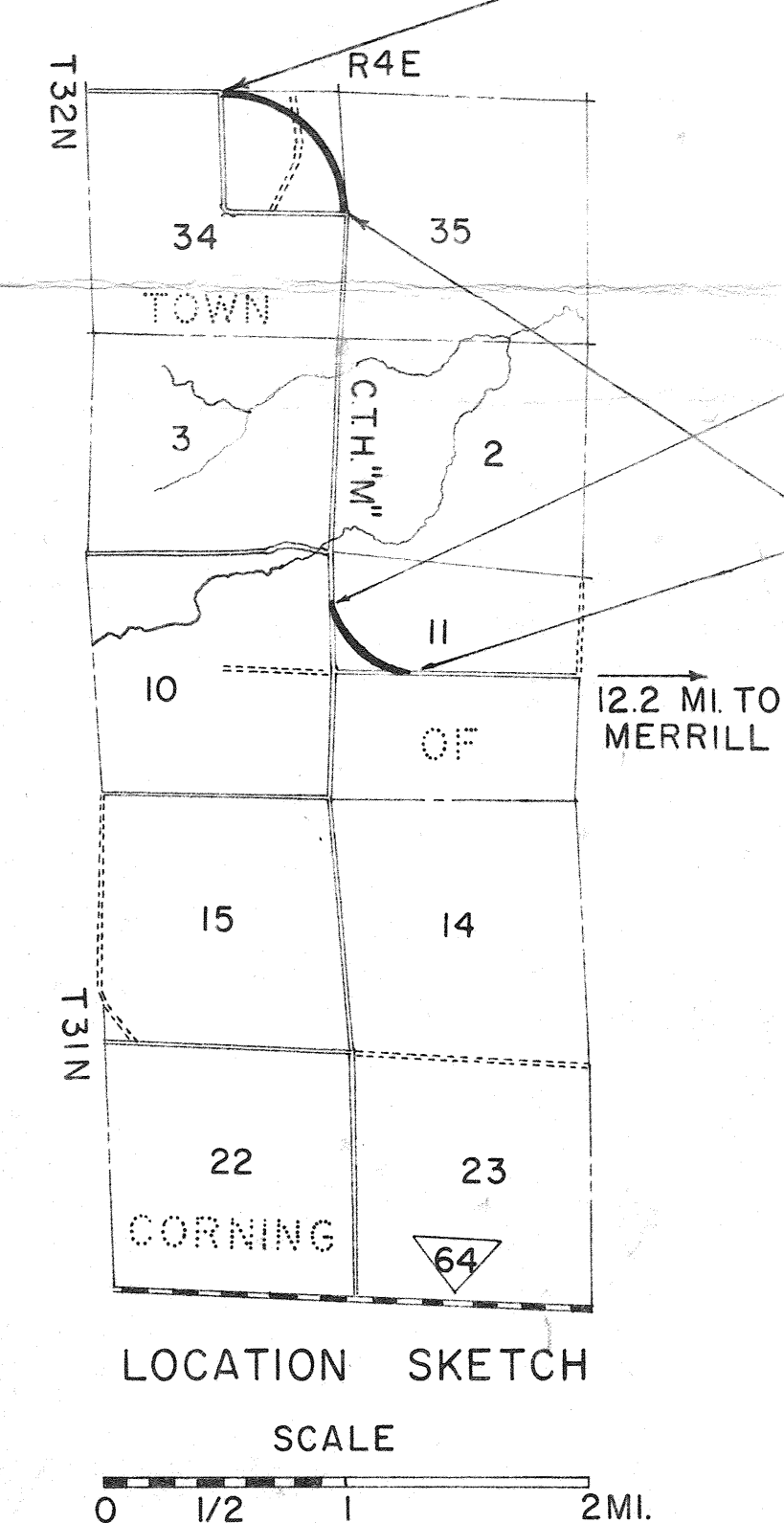


STA. 226+40.8 BEG. OF RELOCATION
