

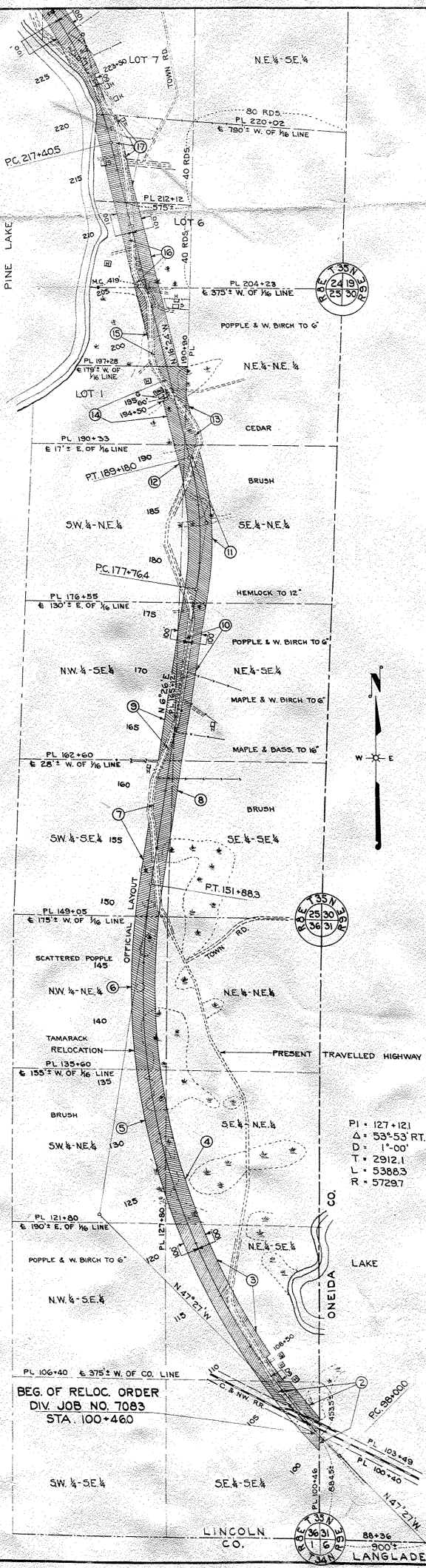

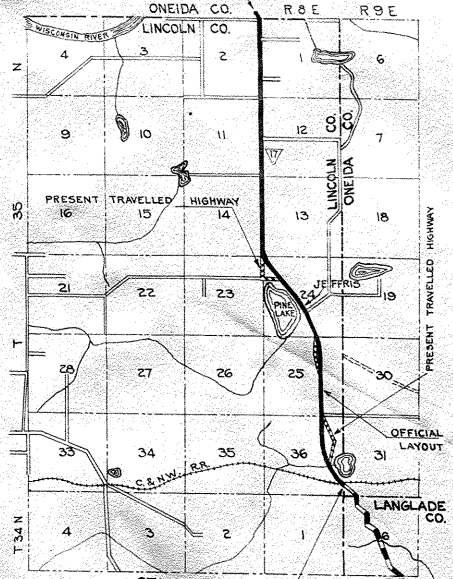

S.T.H. 17 TO RHINELANDER 6 MILES

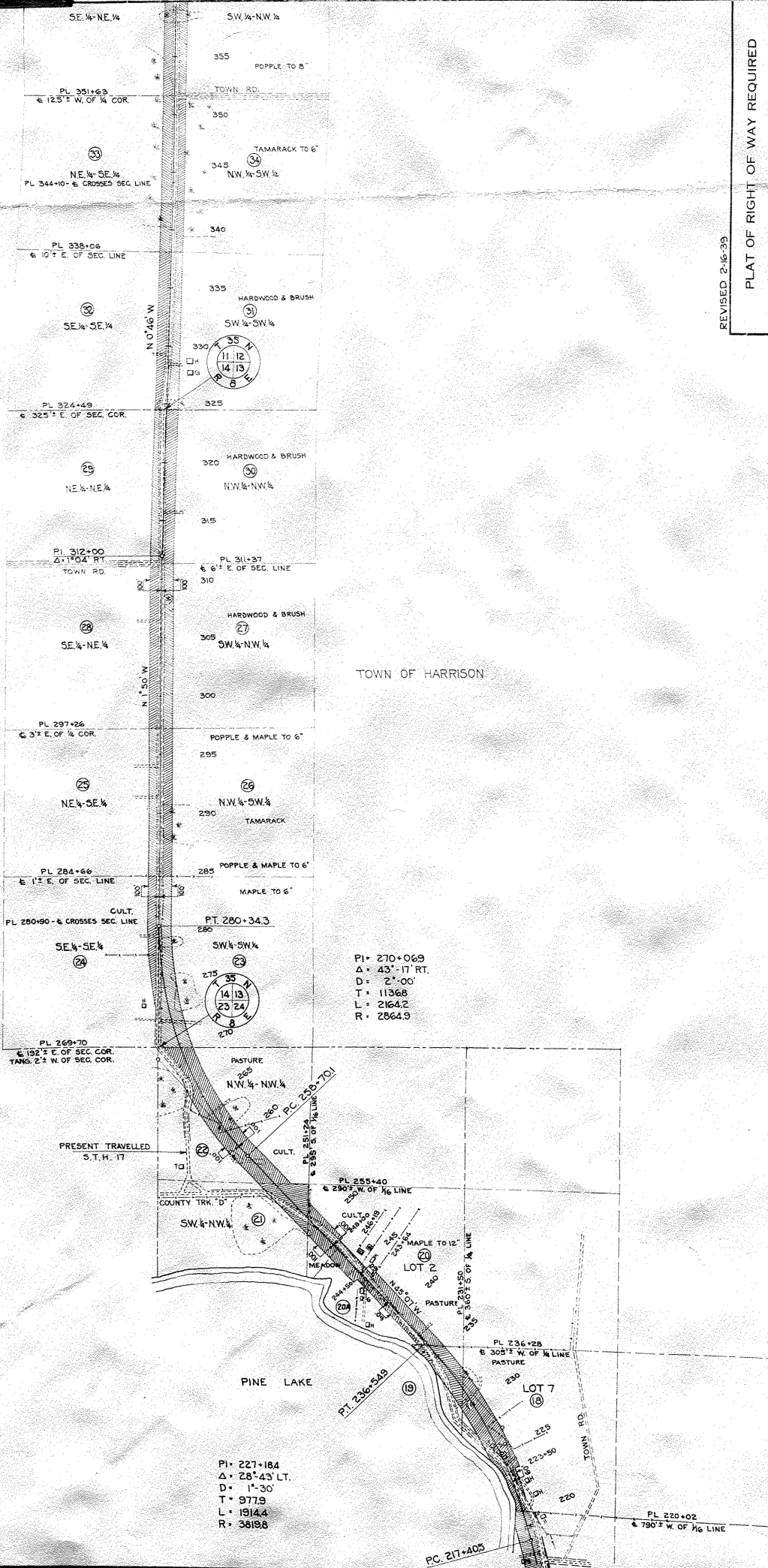

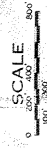

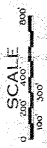

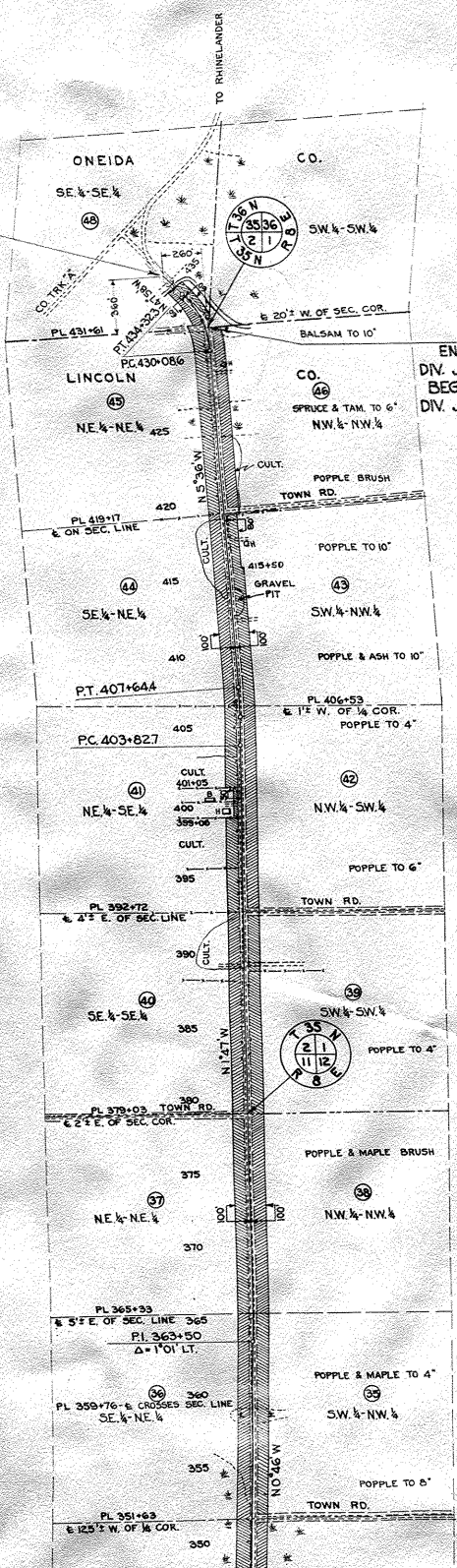
PLAT OF RIGHT OF WAY REQUIRED
