

ORIGINAL SURVEYOR: RICHARD O. CHANEY DATE OF SURVEY: NOVEMBER, 1852




(c)(d)(e) PLAN VIEW OF CORNER WITH TIES TO AT LEAST FOUR WITNESSES. IF IN DISAGREEMENT WITH PREVIOUSLY ESTABLISHED CORNER, SHOW THE DISTANCES BETWEEN THE TWO CORNERS AND ALSO INDICATE THE TIE TO THE DISPUTED CORNER.



WEST 1/4 CORNER SECTION 3, T32N, R05E LINCOLN COUNTY MONUMENT SET




FACING NORTH
