
November 20, 1978 - Surveyor 1383 - William G. Immich - indicates this position as "found iron pipe" on Map M131A.

March 22, 2013 - Surveyor 1102 - Lester J. Schmidt - indicates this position as "2 1/2" o.d. iron pipe topped with a 5" x 6" iron plate which is secured by an iron rod by Burnett in 1923" on Map M625B.

May 24, 2022 - While performing the 2022 Lincoln County PLSS Corner Remonumentation and GPS Services project, I found a 2.5" diameter iron pipe near the computed position provided by Lincoln County. The pipe has a 0.5" iron pin in its center. The monument is ±4 feet west of the centerline of West Circle Drive, on the centerline of East Circle Drive, and ±6" below road grade.

I also found 3 existing witnesses (no record) and I established 4 new reference monuments as shown below.
