

AT FIRST, I WAS NOT GOING TO HOLD THIS PIPE, I WAS GOING TO STRAIGHT LINE SPLIT. AFTER SEEING THAT LINE IS BRUSHED EAST AND WEST, AND RIBBON MARKS THE LINE TO THE NORTH, AND AN ADJOINING LAND OWNER HAD USED THIS CORNER FOR MARKING LINE FOR LOGGING, I DECIDED TO HOLD THE PIPE. THIS IS A "POPULATED" AREA. THERE ARE DRIVEWAYS AND A TRAILER NEAR BY. PULLED OUT 1-1/2" x 5' IRON PIPE AND SET A 5' SWAMP ROD. TIED OUT.
