





03/09/2010: I FOUND A 6" SQUARE GRANITE MONUMENT MOUNDED WITH STONE LOCATED IN A TAG ALDER SWAMP. I SET A PLASTIC POST 2' NORTH OF THE MONUMENT, SET A 3/4" DIA. REBAR ALONG THE EAST SIDE OF THE MONUMENT AND SET FOUR 3/4" DIA. CAPPED REBAR REFERENCE MONUMENTS AS SHOWN BELOW.
