



1854: JACKSON L. PRENTICE SET THE ORIGINAL SECTION CORNER POST.

1930'S: FRANCIS FOX SET A STONE MONUMENT AT THE EDGE OF A SWAMP AND NOTES A 8' X 6' BOULDER 3' ABOVE GROUND MARKED WITH AN "X" - N62°W, 18.2'.

01/20/2010: I FOUND A 6" SQUARE GRANITE MONUMENT IN A ROCK CAIRN AND THE BOULDER NOTED BY FOX. I SET A PLASTIC POST 2' NORTH OF THE MONUMENT, SET A 3/4" DIA. REBAR ALONG THE NORTH SIDE OF THE MONUMENT, MADE TWO BEARING TREES AND SET TWO 3/4" DIA. CAPPED REBAR REFERENCE MONUMENTS AS SHOWN BELOW.

(c)(d)(e) PLAN VIEW OF CORNER WITH TIES TO AT LEAST FOUR WITNESSES. IF IN DISAGREEMENT WITH PREVIOUSLY ESTABLISHED CORNER, SHOW THE DISTANCES BETWEEN THE TWO CORNERS AND ALSO INDICATE THE TIE TO THE DISPUTED CORNER.
