

11/16/2009: I FOUND A BREAK-AWAY MONUMENT 1' BELOW THE SURFACE OF C.T.H. "E" AND 2' NORTH OF CENTERLINE WITH

THE TOP BROKEN OFF. I REPLACED IT WITH A NEW BREAK-AWAY MONUMENT AND SET FOUR 3/4" DIA.

ALUMINUM CAPPED REBAR REFERENCE MONUMENTS AS SHOWN BELOW.

(c)(d)(e) PLAN VIEW OF CORNER WITH TIES TO AT LEAST FOUR WITNESSES. IF IN DISAGREEMENT WITH PREVIOUSLY ESTABLISHED CORNER, SHOW THE DISTANCES BETWEEN THE TWO CORNERS AND ALSO INDICATE THE TIE TO THE DISPUTED CORNER.
