





2004: FOUND AND ACCEPTED 6" X 6" GRANITE STONE MONUMENT IN PLACE 1' ABOVE GROUND AND LEANING OVER IN A MOUND OF STONE. NO BT'S FOUND. OLD RAILROAD GRADE NORTH 88'. PLUMBED STONE MONUMENT, ESTABLISHED TWO BEARING TREES AND SET 2 LINCOLN COUNTY ALUMINUM CAPPED REBAR REFERENCE MONUMENTS AS SHOWN BELOW. SET CARSONITE POST 1' NORTH OF MONUMENT.
