



In 2005 David Renaud found no evidence of the corner's original marker or witness trees, found no usable evidence of occupation or other indications of the corner's location in Section 8 except for a pipe that appears to be at the center of section, but found several fence lines in Section 9 along 1/4 and 1/4-1/4 lines that measured reasonably well between themselves. He accepted the locations of the fence lines and the centerline of Cloverbelt Rd. as the best available evidence for the corner's original location. He determined the East and West location of the corner from said centerline and the North & South location to be in a spot that best fit all fence lines mentioned above. This location fell directly Easterly of the pipe he found at the center of Section 8. He set a Lincoln Co. Berntsen monument at the corner.

April 2015. The corner was found to be set at the wrong location based on the section summary and the notes above. The Berntsen monument set by Renaud was moved to the correct position and re—tied as shown below.




