



(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

An existing fence, more or less on line, was found in place, running Westerly of the corner. A Berntsen W-1-C was set in place.

The NW corner of the SW4 of the NW4 of Sec. 18 has been previously found in place and monumented by the Wisconsin Department of Transportation. This corner is a 2" iron pipe. The SW corner of Sec. 19 had been previously monumented and a Berntsen monument was found in place. This corner was established by single porportional measurement between these two corners.

All bearings are referenced to the East line of the SE 4 of Section 18, assumed as bearing N O h2' E.

The NW corner of the SW4 of the NW is N O 15'14" E, 1315.54' from this corner and the SW corner of Section 19 is S O 45'44" W, 7893.24' from this corner.
