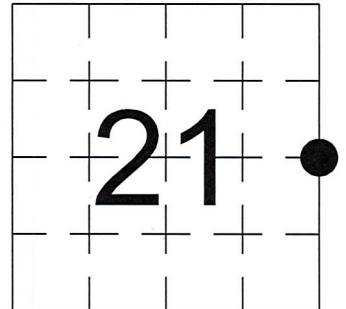

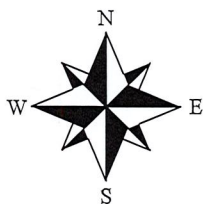

1923, D.S. Burnett set 2" I.P. with square plate on top.

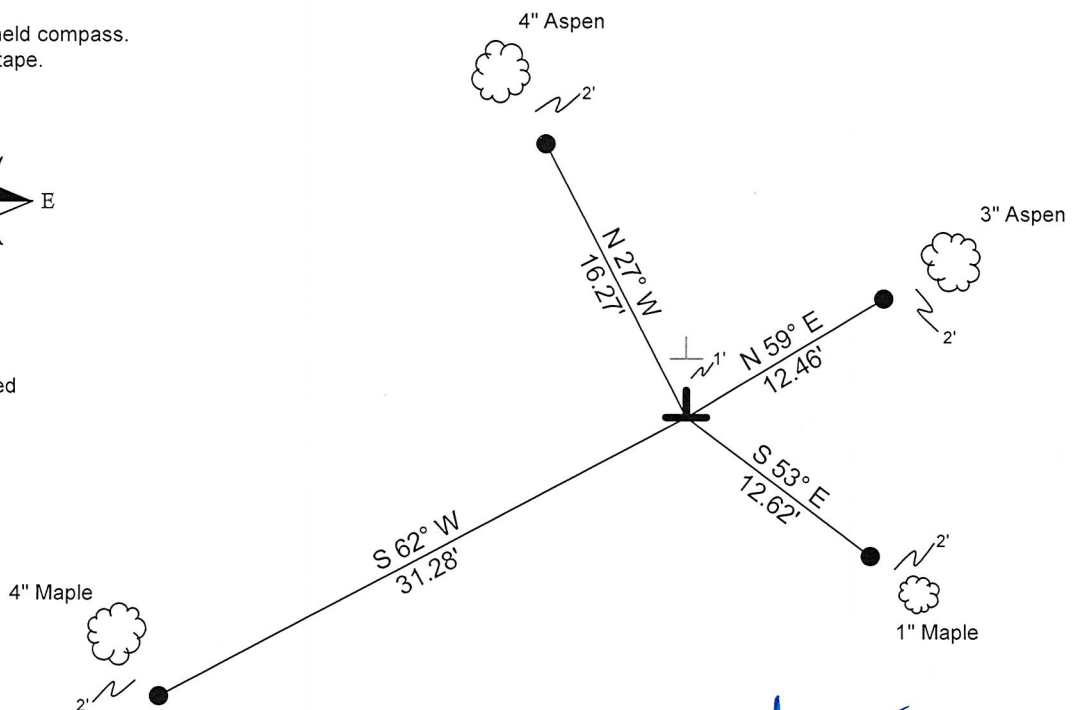
2/16/2023, I, Anthony R. Dallman, PLS-2405, found no evidence of the corner position, there was a 66" steel "T" post at the location. I set said "T" post, at single proportioned position between the NE and SE Corners of Section 21, up 13". I accepted this location and set witness monuments, as shown in the sketch below, to further perpetuate the corner location.
