**Parcel 1 Legal Description**

A parcel of land being part of the Northeast Quarter of the Southwest Quarter of Section 2, Township 35 North, Range 8 East, Town of Harrison, Lincoln County, Wisconsin, shown as Parcel 1 on Maines and Associates Map No. 2025355, dated December 29, 2025, and being more particularly described as follows:

Commencing at the southwest corner of said Section 2 marked by a steel nail; thence along the south line of said Section 2, N87°15'02"E for a distance of 1365.06 feet to the west sixteenth corner; thence along the west line of the Southeast Quarter of the Southwest Quarter, N02°04'11"W for a distance of 1311.41 feet to the southwest sixteenth corner marked by a steel nail; thence along the west line of said Northeast Quarter of the Southwest Quarter, N02°04'11"W for a distance of 655.61 feet to the northwest corner of Lot 2 of Certified Survey Map No. 2244, the PLACE OF BEGINNING. Thence continuing along said west line, N02°04'11"W for a distance of 205.00 feet; thence leaving said west line, N85°56'11"E for a distance of 38.52 feet to an iron pipe on the easterly right-of-way line of Thisis Road; thence continuing N85°56'11"E for a distance of 650.24 feet to an iron pipe; thence S02°04'11"E for a distance of 205.00 feet to an iron pipe on the north line of said Lot 2 of Certified Survey Map No. 2244; thence along said north line, S85°56'11"W for a distance of 650.00 feet to an iron pipe on the easterly right-of-way line of Thisis Road; thence continuing along said north line, S85°56'11"W for a distance of 38.76 feet to the PLACE OF BEGINNING. Subject to the rights of the public over the Town Road known as Thisis Road.

Together with and subject to any easements, restrictions, and reservations of record or of use.




**Surveyor's Certificate**
