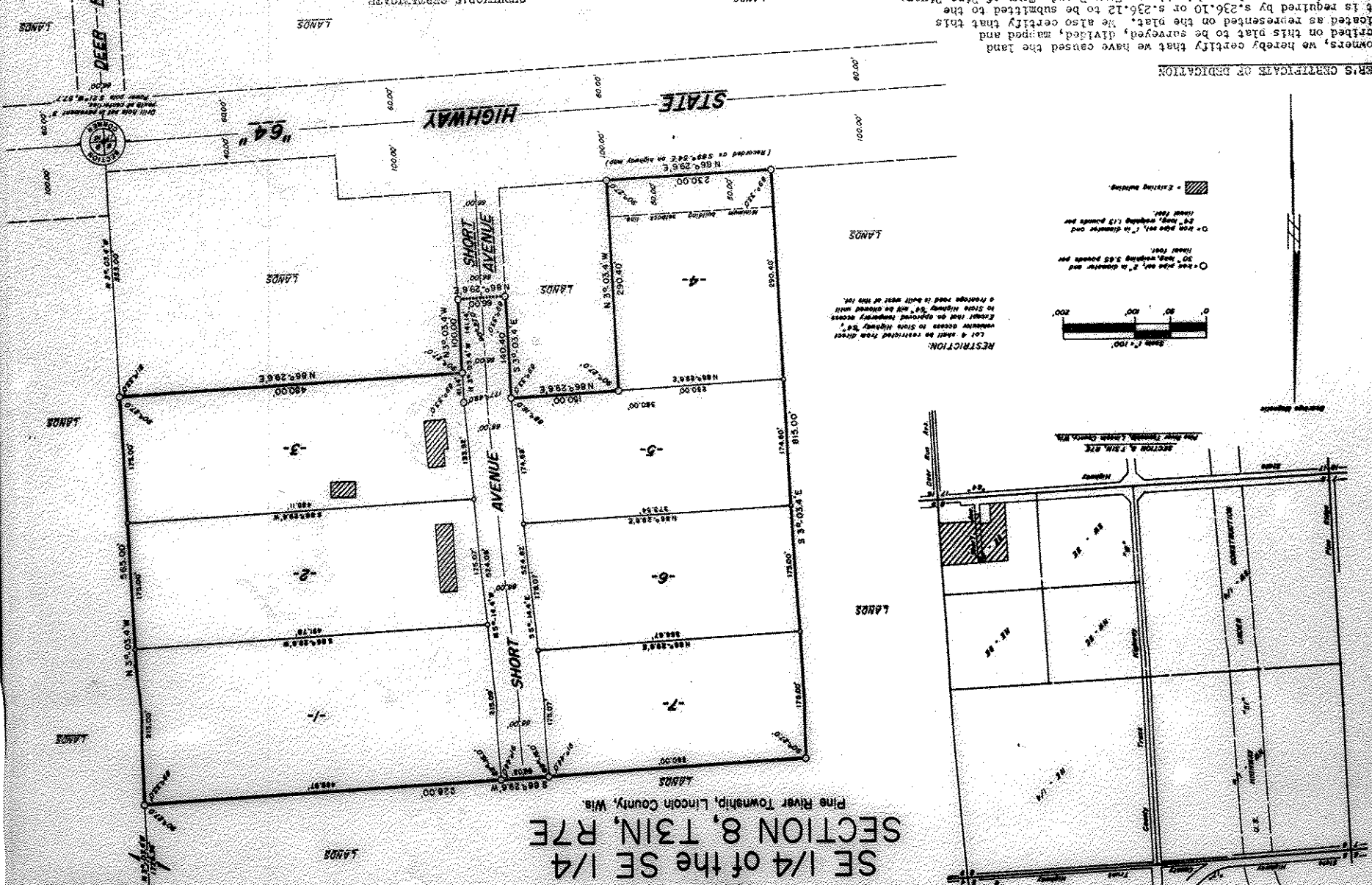

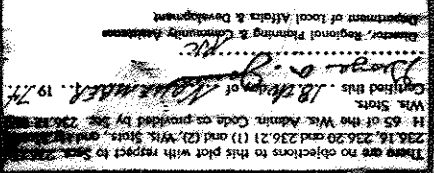


I, Robert H. Wint, Registered Land Surveyor No. S-1040, hereby certify that in full compliance with the provisions of Chapter 236 of the Wisconsin Statutes and the subdivision regulations of the Town of Pine River, and under the direction of Otto P. Zastrow and Evelyn Zastrow, owners of said land, I have surveyed, divided and mapped ZASTROWLAND, that such plat correctly represents all exterior boundaries and the subdivision of the land surveyed.

Being a parcel of land in the SE 1/4 of the SW 1/4, Section 8, T31N, R7E, Lincoln County, Wisconsin, more particularly described as follows:  
Commencing at the section corner common to Sections 8, 9, 16 and 17, marked by a dill hole in the pavement of State Highway 64; thence N3°-03'-41"W, 353.00 feet along the east line of Section 8 to the place of beginning, marked by an iron pipe;  
thence containing N3°-03'-41"W, 565.00 feet along the east line of Section 8 to an iron pipe, thence S86°-29'-61"W, 926.00 feet to an iron pipe;  
thence S3°-03'-41"E, 815.00 feet to an iron pipe on the northern right-of-way line of State Highway 64; thence N86°-29'-61"E, 230.00 feet along said northern right-of-way line to an iron pipe, thence N3°-03'-41"W, 290.40 feet to an iron pipe;  
thence N86°-29'-61"E, 150.00 feet to an iron pipe; thence N86°-29'-61"E, 66.00 feet along the northern end of Short Avenue to an iron pipe;  
thence N3°-03'-41"W, 100.00 feet to an iron pipe; thence N86°-29'-61"W, 480.00 feet to the place of beginning.
