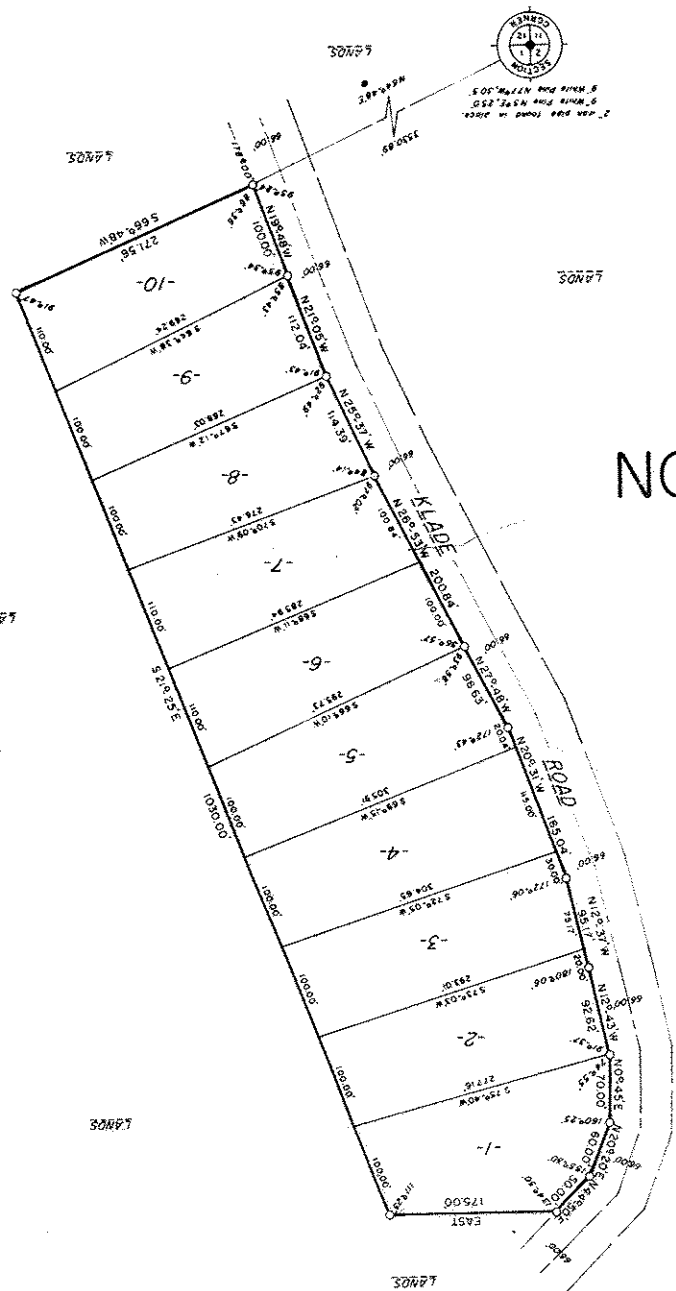
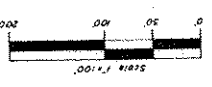

 SURVEYOR'S CERTIFICATE

That in full compliance with the provisions of Chapter 236 of the Wisconsin Statutes and the subdivision regulations of the Town of Bradley, and under the direction of LAWRENCE LADICK, INC., owner of said land, I have surveyed, divided and mapped LADICK NOKOMIS SUBDIVISION; that such plat correctly represents all exterior boundaries and the subdivision of the land surveyed; being a parcel of land in the NW 1/4 of the SE 1/4, Section 1, T35N, R6E, Lincoln County, Wisconsin, more particularly described as follows:

Commencing at the Section corner common to Sections 1, 2, 11 and 12, marked by an iron pipe; thence N44°48'E, (solar bearing) 350.89 feet to the place of beginning; marked by an iron pipe. Thence N19°48'W, 100.00 feet to an iron pipe; thence N21°05'W, 112.04 feet to an iron pipe; thence N25°37'W, 114.39 feet to an iron pipe; thence N27°48'W, 96.63 feet to an iron pipe; thence N20°31'W, 167.04 feet to an iron pipe; thence N12°43'W, 92.62 feet to an iron pipe; thence N0°45'E, 70.00 feet to an iron pipe; thence N20°20'E, 60.00 feet to an iron pipe; thence N44°50'E, 50.00 feet to an iron pipe; thence N20°00'W, 175.00 feet to an iron pipe; thence S21°25'E, 1030.00 feet to an iron pipe; thence S66°48'W, 271.56 feet to the place of beginning.

That 0.1 ton pipe two inches in diameter and 30 inches long, minimum weight 3.05 pounds per lineal foot. All other lot corners monumented with iron pipe one inch in diameter and 24 inches long, minimum weight 1.13 pounds per lineal foot.
