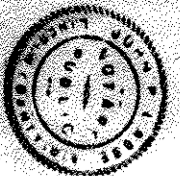

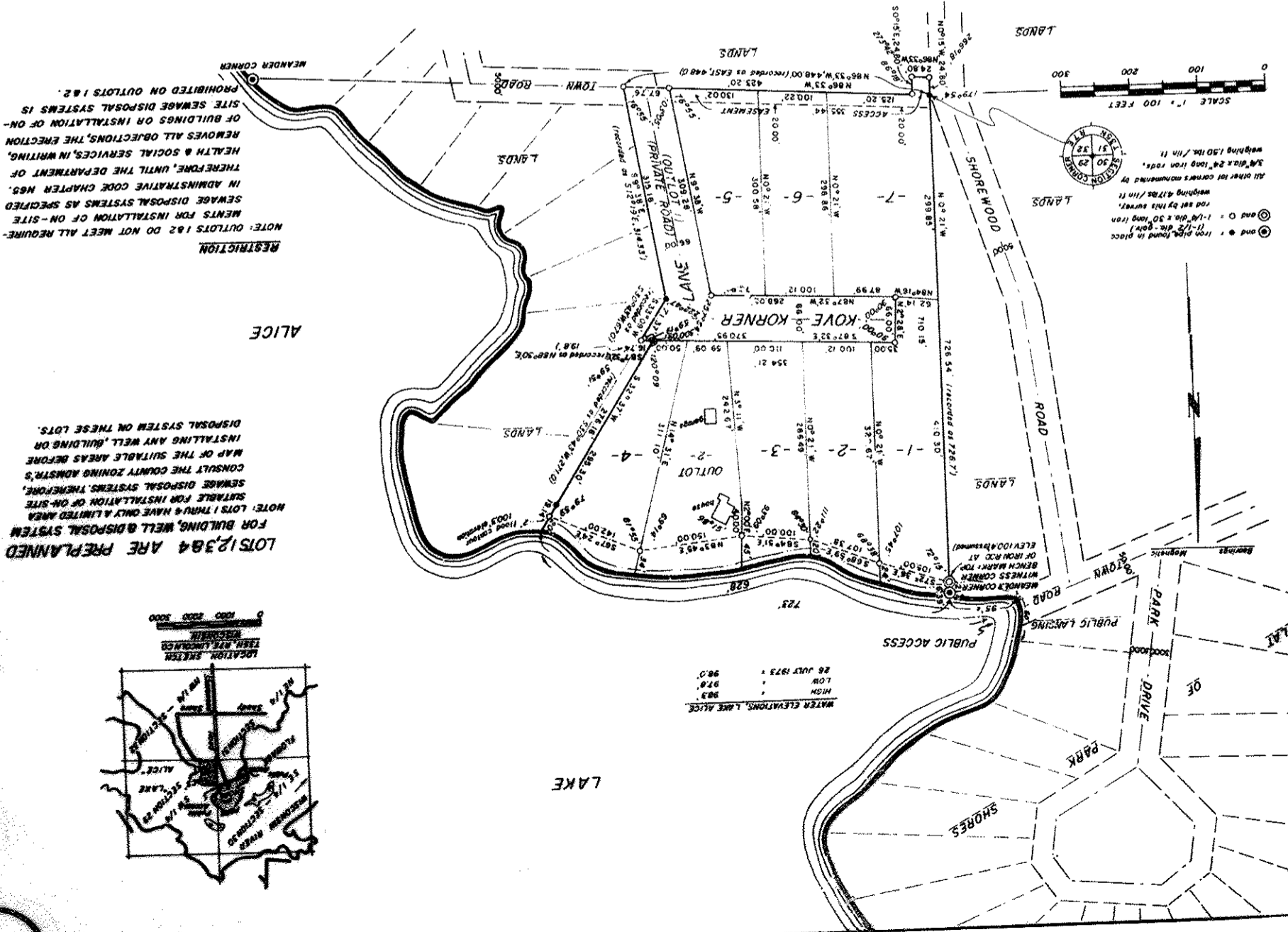

I, Robert H. Winat, Registered Land Surveyor, hereby certify:  
That in full compliance with the provisions of Chapter 236 of the Wisconsin Statutes  
and the subdivision regulations of the County of Lincoln and Town of King and under  
the direction of Frank S. Kovacs, owner of said land, I have surveyed, divided and  
mapped KOVACS' KOVE, a portion of land in the SW 1/4 of the NW 1/4 of Section 32  
and the SW 1/4 of Section 29, all in Town 35 North, Range 7 East,  
the subdivision of the land surveyed being a parcel of land in the SW 1/4 of the NW 1/4,  
including all lands lying between the meander line and the shore of Lake Alice.  
Beginning at the southeast corner of Section 29, marked by an iron pipe then N 02° 15'  
E 210.15 feet to a witness corner marked by an 1-1/2" dia. iron bar,  
said corner witness the boundary shore of Lake Alice; then meandering along the  
iron pipe S 72° 03' E, 105.00 feet, S 68° 50' E, 102.78 feet, S 84° 51' E, 100.00 feet,  
take, S 72° 03' E, 152.00 feet to an iron bar; then S 72° 03' E, 150.00 feet and S 67° 24' E,  
205.30 feet to an iron pipe; then S 70° 32' E, 16.74 feet to an iron bar; then  
S 33° 09' W, 71.37 feet to an iron pipe; then S 09° 31' E, 315.18 feet to an iron bar on  
the section line; then N 86° 33' W, 24.80 feet to an iron bar; then S 01° 15' E, 24.80  
feet to an iron bar; then N 86° 33' W, 24.80 feet to the place of beginning.  
Including all lands lying between the meander line and the shore of Lake Alice.

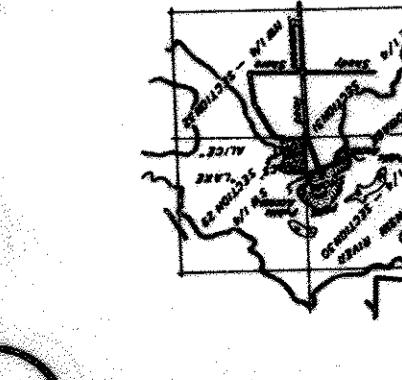

IN ADMINISTRATIVE CODE CHAPTER M65.  
THEREFORE, UNTIL THE DEPARTMENT OF  
HEALTH & SOCIAL SERVICES, IN WRITING,  
REMOVES ALL OBJECTIONS, THE ERECTION  
OF BUILDINGS OR INSTALLATION OF ON-  
SITE SEWAGE DISPOSAL SYSTEMS IS  
PROHIBITED ON OUTLOTS 1&2.

NOTE: LOTS 1, 3&4 HAVE ONLY A LIMITED AREA  
SUITABLE FOR INSTALLATION OF ON-SITE  
SEWAGE DISPOSAL SYSTEMS. THEREFORE,  
CONSULT THE COUNTY ZONING ADMINISTRATOR  
MAP OF THE SUITABLE AREAS BEFORE  
INSTALLING ANY WELL, BUILDING OR  
DISPOSAL SYSTEM ON THESE LOTS.

FOR BUILDING, WELL & DISPOSAL SYSTEM  
SUITABLE FOR INSTALLATION OF ON-SITE  
SEWAGE DISPOSAL SYSTEMS, THEREFORE,  
CONSULT THE COUNTY ZONING ADMINISTRATOR  
MAP OF THE SUITABLE AREAS BEFORE  
INSTALLING ANY WELL, BUILDING OR  
DISPOSAL SYSTEM ON THESE LOTS.
