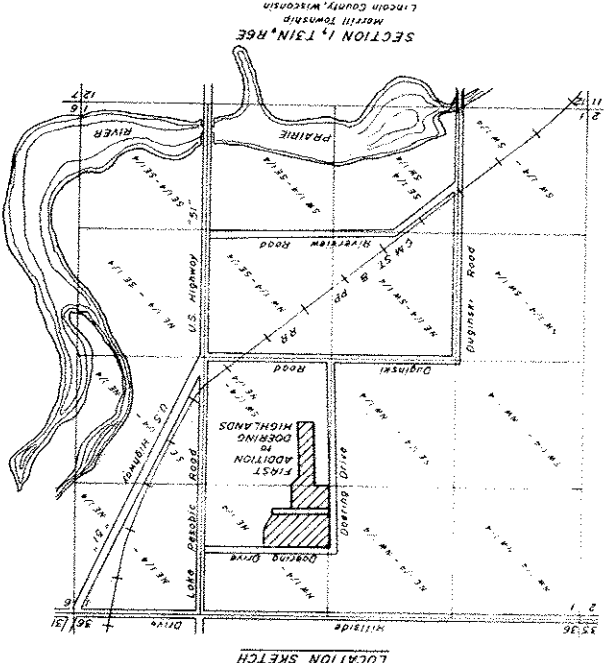

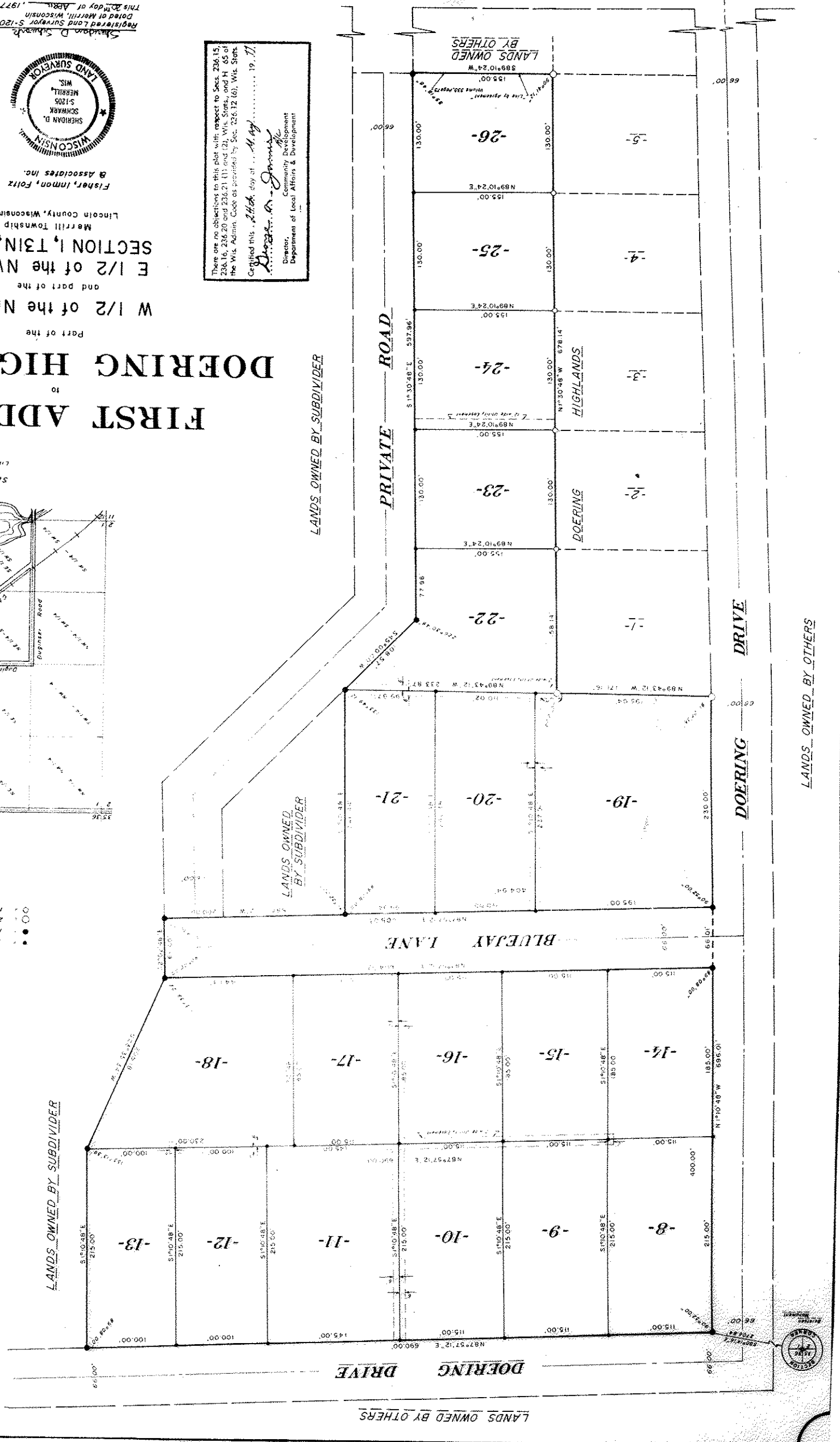
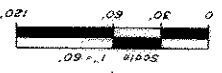

SURVEYOR'S CERTIFICATE

I, Sheridan D. Schwark, Registered Land Surveyor No. S-1205, hereby certify: that in full compliance with the provisions of Chapter 236 of the Wisconsin Statutes and the subdivision regulations of the City of Merrill and the Town of Merrill, and under the direction of Reid Doring, I have surveyed, divided and mapped the First Addition to Doering Highlands, that such plat correctly represents all exterior boundaries and the subdivision of the land surveyed:

Being a parcel of land in the NW 1/4 & SW 1/4 of NE 1/4, & NE 1/4 & SE 1/4 of NW 1/4, Section 1, T31N, R6E, Merrill Township, Lincoln County, Wisconsin, more particularly described as follows:

Commencing at the section corner common to Sections 1, 2, 35 and 36, marked by a Bernster Monument 25.5 feet West of the intersection of Hillside Drive and County Trunk Highway "K", witnessed by a 1" iron pipe bearing N55°E, 70.0 feet, a 1" iron pipe bearing S45°E, 85.0 feet, a 1" iron pipe bearing S45°W, 70.0 feet and a 1" iron pipe bearing N45°W, 60.0 feet; thence S80°14'16"E, 2706.84 feet to the place of beginning, marked by a 1-1/2" solid iron rod on the southerly and easterly right of way line of Doering Drive.
