SURVEYOR'S CERTIFICATE

I, Sheridan D. Schwark, Registered Land Surveyor, hereby certify: That in full compliance with the provisions of Chapter 236 of the Wisconsin Statutes and the subdivision regulations of the Town of Merrill and the Town of Rock Falls, and under the direction of Leonard Collins and Shirley Ann Jacobi, I have surveyed, divided and mapped Rose-Len Heights, that such plat correctly represents all exterior boundaries and the subdivision of the land surveyed, and that this land is located in all of Gov't Lot 1, Section 30, T32N, R6E, Merrill Township and part of Gov't Lot 1, Section 25, T32N, R5E, Rock Falls Township, Lincoln County, Wisconsin, more particularly described as follows:

Commencing at the section corner common to Sections 30, 31, 36, and 25, marked by a 2" iron pipe; thence N0°06'12"E, 1291.48 feet to the place of beginning, located on the southerly right of way line of River Road.

Thence S89°13'58"E, 1591.03 feet along said right of way line to a point on the East line of Government Lot 1, Section 30, T32N, R6E, thence S0°01'39"E, 1092.20 feet along said line to a point on the meander line of the Wisconsin River; thence meandering along the shore of the Wisconsin River N82°20'31"W, 423.24 feet, N50°18'50"W, 322.59 feet, N82°05'29"W, 197.90 feet, N44°22'12"W, 201.66 feet, N54°35'18"W, 301.44 feet, N47°45'54"W, 225.60 feet and N26°12'01"W, 393.90 feet to the place of beginning.
