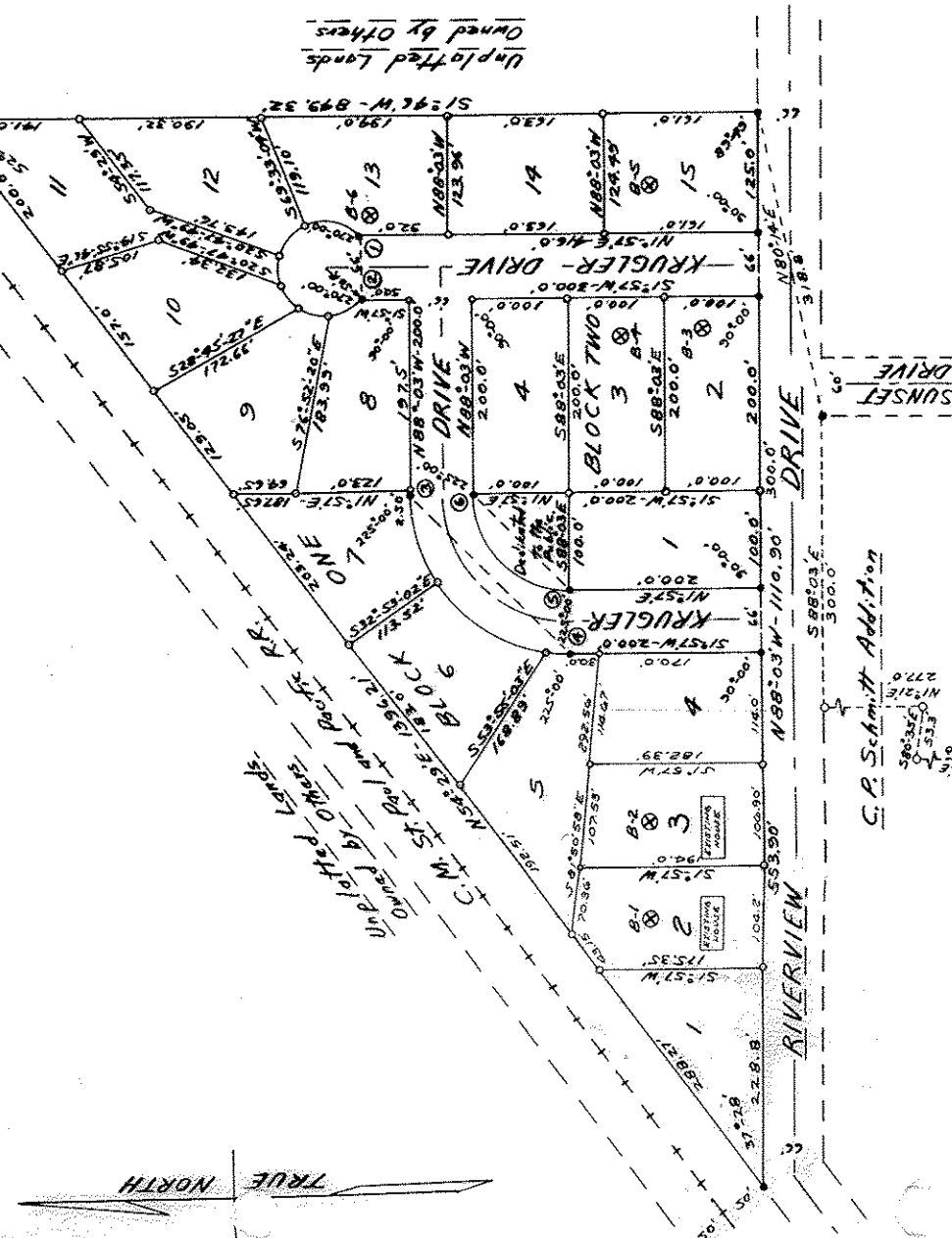
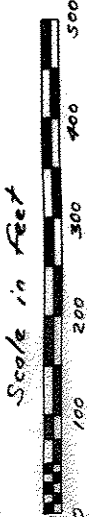


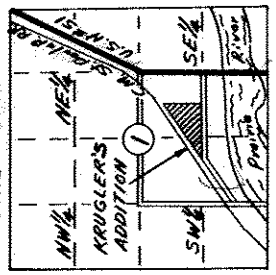
# KRUGLER'S ADDITION
