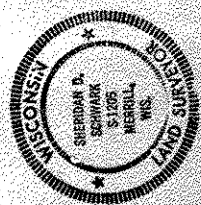


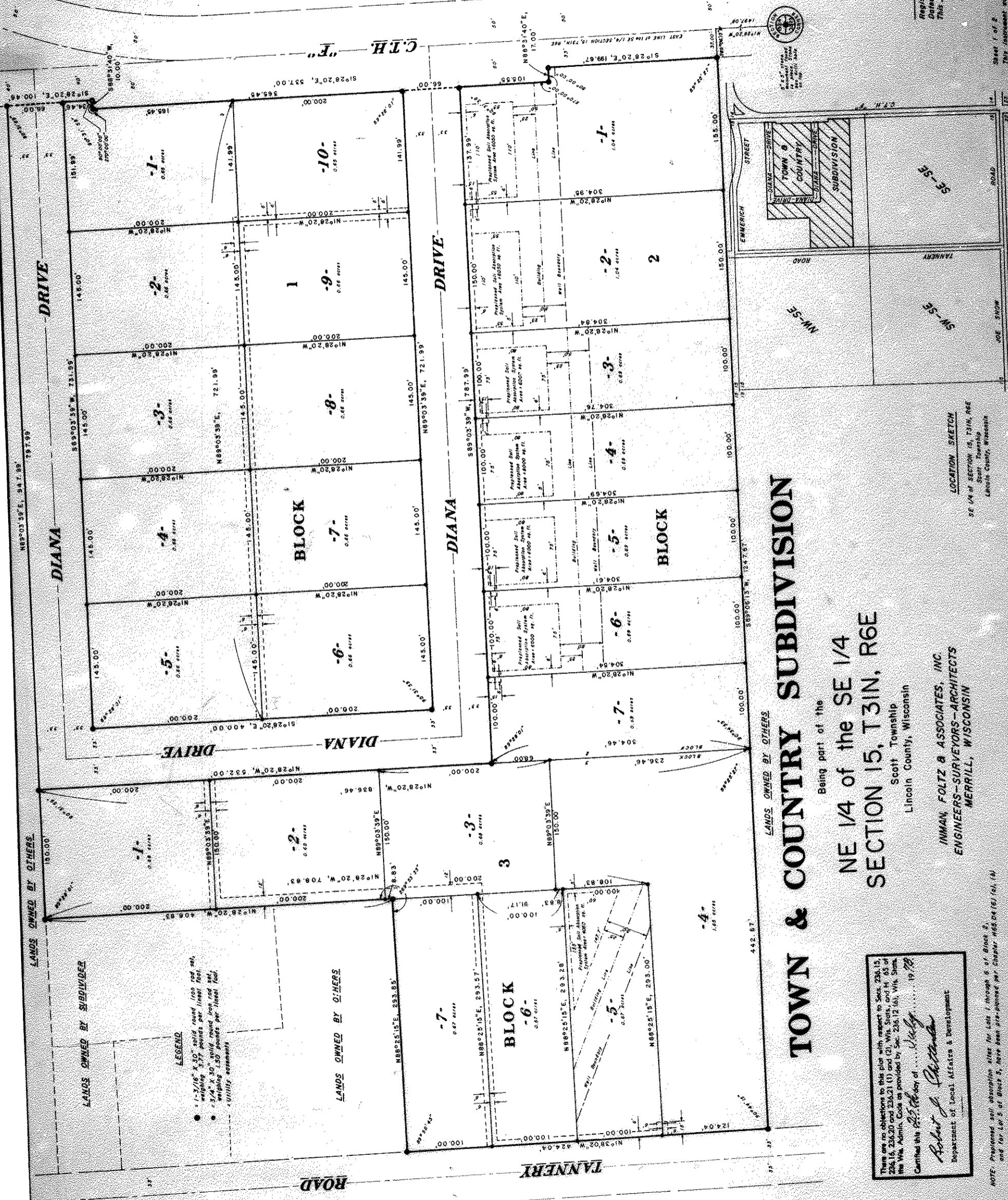

SURVEYOR'S CERTIFICATE

I, Sheridan D. Schwark, Registered Land Surveyor No. S-1205, hereby certify that in full compliance with the provisions of Chapter 236 of the Wisconsin Statutes and the subdivision regulations of the City of Merrill and the Town of Scott, and under the direction of Michael J. Galkin and Thomas N. Tylenda, I have surveyed, divided and mapped Town & Country Subdivision; that such plat correctly represents all exterior boundaries and the subdivision of the land surveyed:

Being a parcel of land in the NE 1/4 of the SE 1/4, Section 15, T31N, R6E, Scott Township, Lincoln County, Wisconsin, more particularly described as follows:

Commencing at the section corner common to Sections 14, 15, 22, and 23, marked by a 5" x 5" stone monument; thence N1°28'20"W, 1497.08 feet along the east line of said SE 1/4 of Section 15, T31N, R6E; thence S89°06'13"W, 33.00 feet to a point on the westerly right-of-way of C.T.R. "A", the place of beginning.

Thence continuing S89°06'13"W, 1247.67 feet to the easterly right-of-way of Tannery Road; thence N1°38'02"W, 424.04 feet along said right-of-way; thence N88°25'15"E, 293.85 feet; thence N1°28'20"W, 408.83 feet; thence N89°03'39"E, 947.99 feet to the westerly right-of-way of C.T.R.
