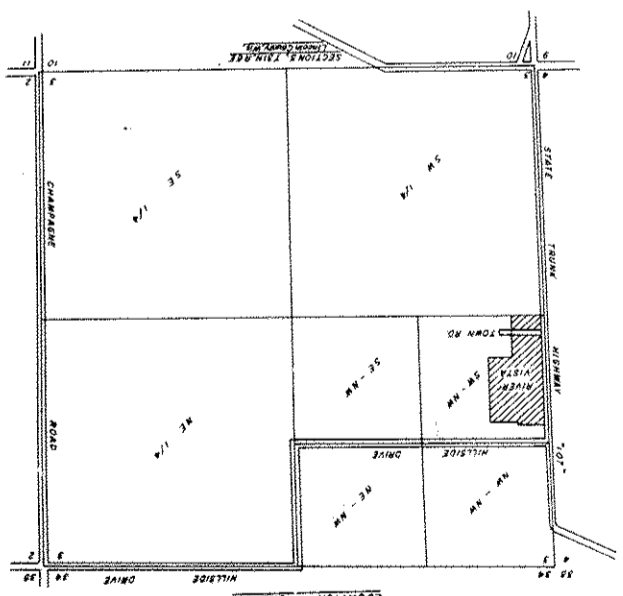
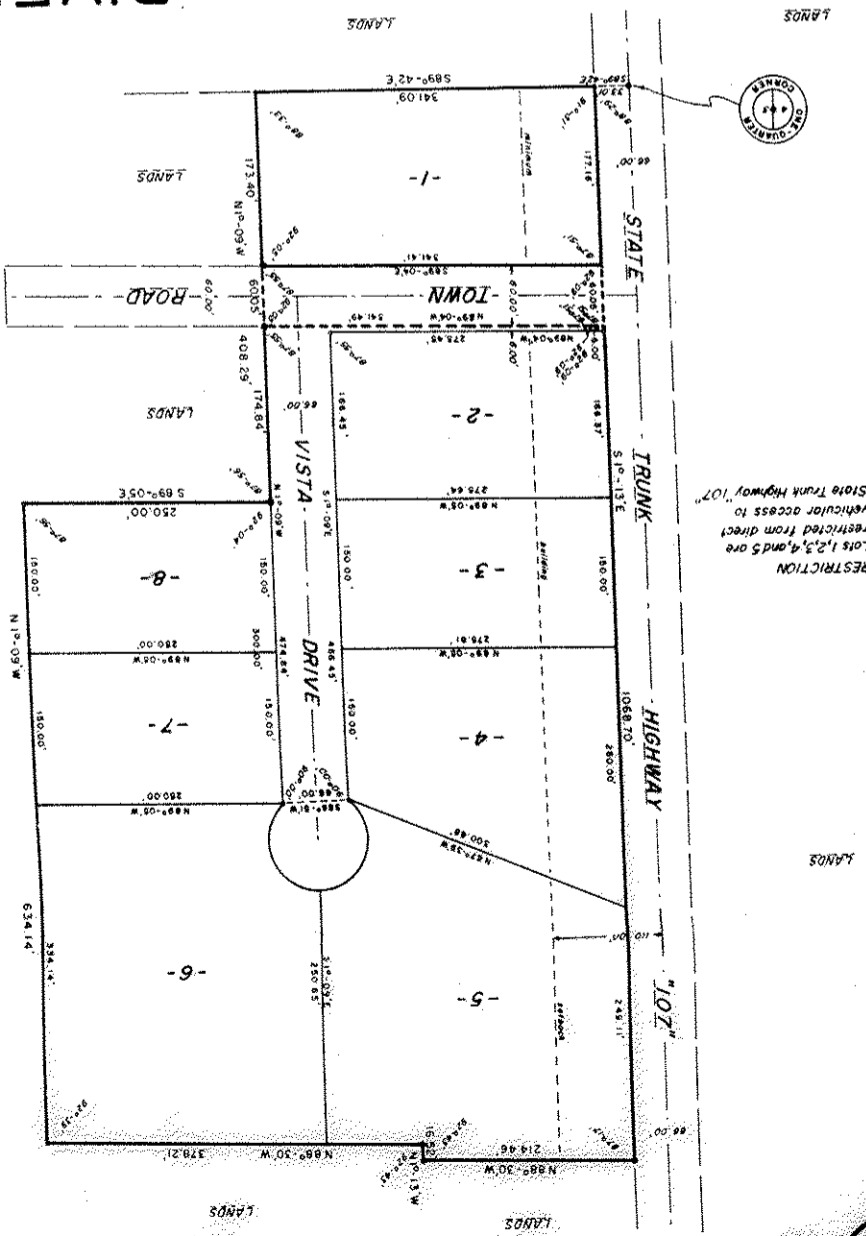

 I, \_\_\_\_\_, registered land surveyor, hereby certify: That in full compliance with the provisions of Chapter 236 of the Wisconsin Statutes and the subdivision regulations of the Town of Merrill and under the direction of Gay E. Oberg and Sally L. Oberg, owners of said land, I have surveyed, divided, and mapped RIVER VISTA, that such plat correctly represents all exterior boundaries and the subdivision of the land surveyed; being a parcel of land in the SW 1/4 of the NW 1/4, Section 3, T31N, R6E, Lincoln County, Wisconsin, more particularly described as follows:  
 Commencing at the one-quarter corner common to Section 3 & 4, marked by an iron pipe in the centerline of State Trunk Highway "107", thence S 89°-42'E, 33.01 feet along the B-M line to an iron pipe on the east right-of-way line of State Trunk Highway "107", the place of beginning.  
 Thence continuing S 89°-42'E, 341.09 feet along the B-M line to an iron pipe on the east right-of-way line of State Trunk Highway "107", the place of beginning.  
 Thence S 89°-05'E, 250.00 feet to an iron pipe; thence S 89°-05'E, 250.00 feet to an iron pipe; thence N 1°-09'W, 408.29 feet to an iron pipe; thence N 1°-09'W, 634.14 feet to an iron pipe; thence N 88°-30'W, 378.21 feet to an iron pipe; thence N 88°-30'W, 16.52 feet to an iron pipe; thence N 88°-30'W, 214.46 feet to an iron pipe on the east right-of-way line of State Trunk Highway "107", thence S 1°-13'E, 1066.70 feet along the east right-of-way line of State Trunk Highway "107" to the place of beginning.

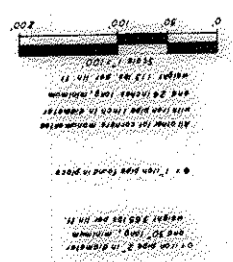
