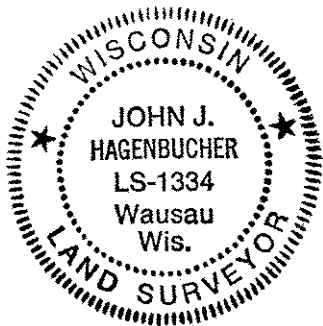

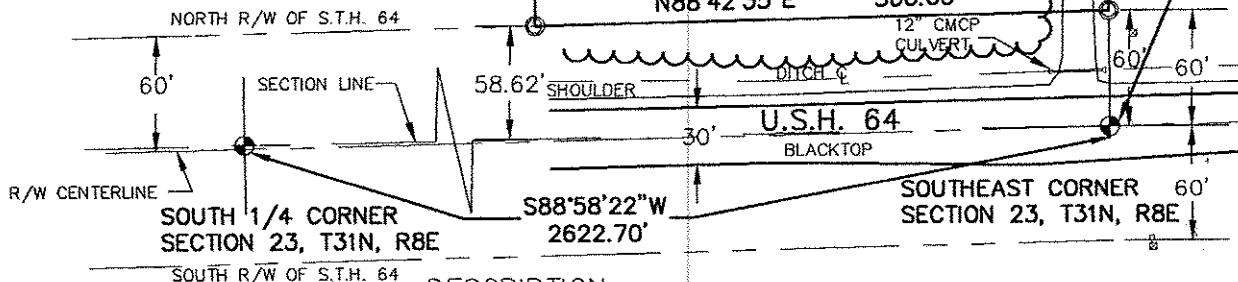
GRAPHIC SCALE

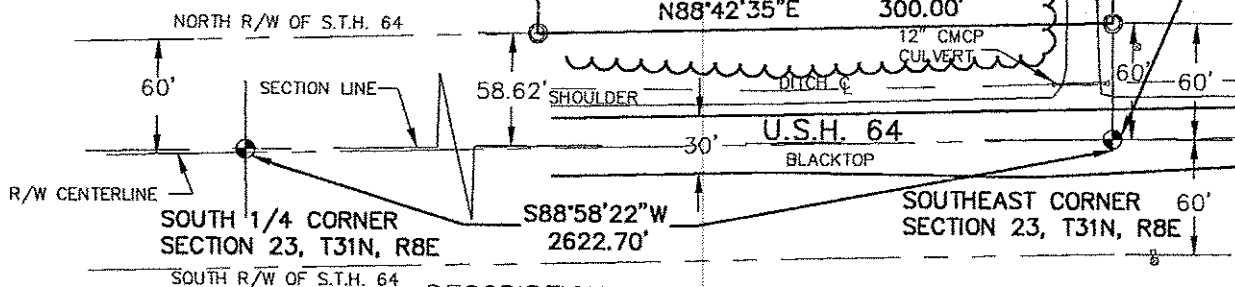
GRAPHIC SCALE
