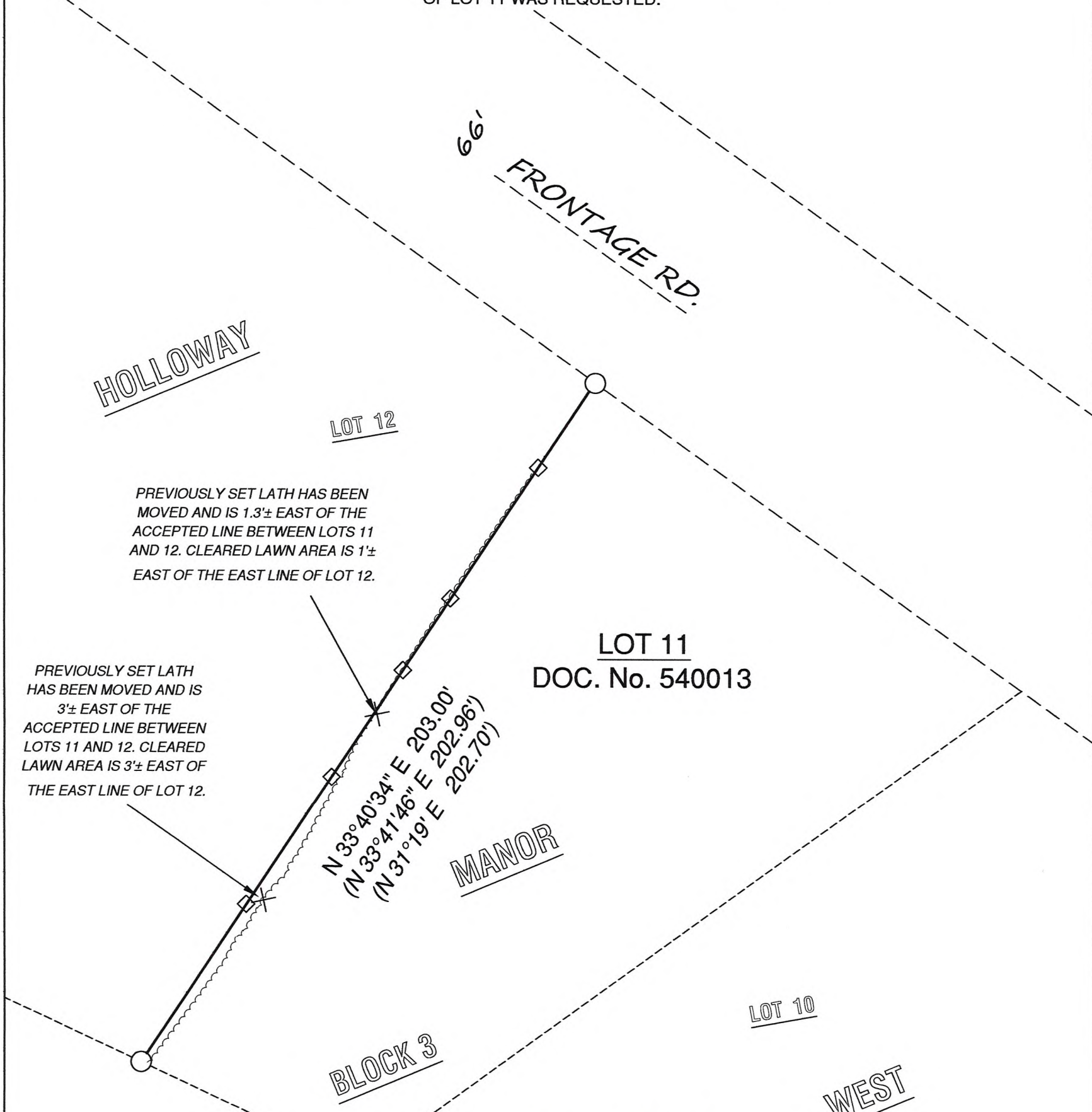


RETRACEMENT SURVEY

 EAST OF THE EAST LINE OF LOT 12.

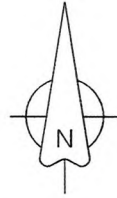
PREVIOUSLY SET LATH

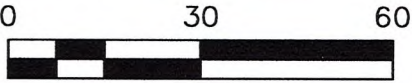
