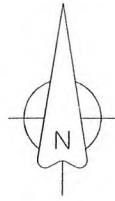


MAP OF SURVEY

COUNTY, WISCONSIN

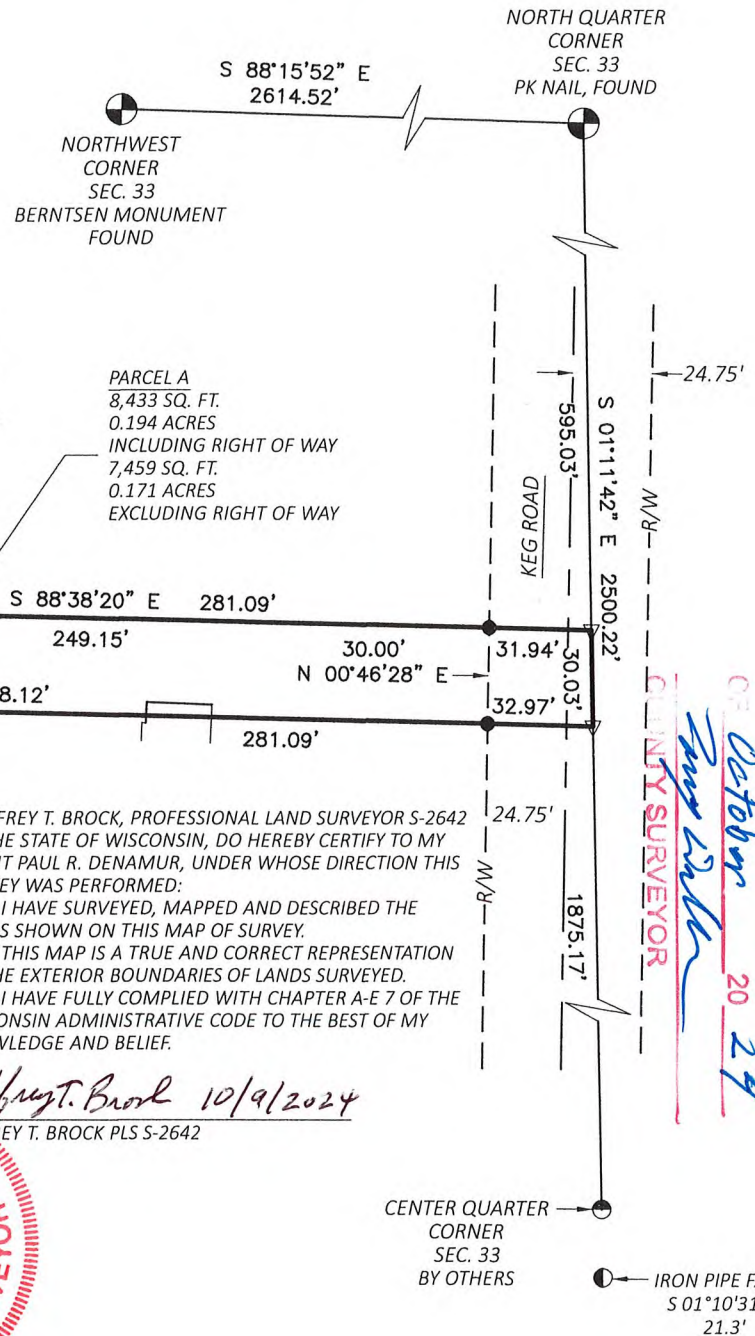

LEGAL DESCRIPTION

PART OF THE NORTHEAST 1/4 OF THE NORTHWEST 1/4 OF SECTION 33, TOWNSHIP 35 NORTH, RANGE 8 EAST, TOWN OF HARRISON, LINCOLN COUNTY, WISCONSIN MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHWEST CORNER OF SAID SECTION 33; THENCE S 88°15'52" E ALONG THE NORTH LINE OF THE NORTHWEST QUARTER OF SAID SECTION 33 2614.52' TO THE NORTH QUARTER CORNER OF SAID SECTION 33; THENCE S 1°11'42" E ALONG THE EAST LINE OF THE NORTHWEST QUARTER OF SAID SECTION 33 625.06' TO THE NORTH LINE OF THE SOUTH HALF OF SAID NORTHEAST 1/4 OF THE NORTHWEST 1/4 AND THE POINT OF BEGINNING;

THENCE N 88°38'20" W ALONG SAID NORTH LINE OF THE SOUTH HALF OF SAID NORTHEAST 1/4 OF THE NORTHWEST 1/4 281.09';  
THENCE N 01°11'42" W 30.03';  
THENCE S 88°38'20" E 281.09' TO THE EAST LINE OF SAID NORTHEAST 1/4 OF THE NORTHWEST 1/4 SECTION 33;  
THENCE S 01°11'42" E 30.03' THE POINT OF BEGINNING.
